40.4 To consider End of Semester Summary Report (Winter 2018)

A summary of various activities of academics undertaken in previous semester (Winter 2018) including performance of UG/PG/Ph.D is placed at <u>Annexure III</u>

40.5 To report the academic calendar for Winter 2019

Academic Calendar for Winter Semester 2019, which was approved by Chairman, Senate is placed at <u>Annexure IV</u> for ratification.

40.6 To report status of application to NBA for Accreditation of B.Tech.(ECE) program

Due to some technical issues the pre-qualifier submitted by us earlier didn't get accepted by NBA. We have again submitted the pre-qualifier recently and are waiting for the acceptance, further to which SAR will be prepared.

40.7 To report QS Ranking 2019 of IIITD

IIITD secured 48 position in QS India Rankings, 192 in QS BRICS ranking and 301-350 in QS Asian Ranking 2019. In all 75 Universities have been ranked in India rankings and 403 in BRICS Rankings out of which 86 were from India. Last year our rank was 181-190 in

QS BRICS Ranking. IIITD is among the top 48% in QS BRICS Rankings. Some detailed analysis of parameters is placed at Annexure V.

A committee of 3 Faculty members, Dr Richa, Dr Debajyoti and Dr Shobha has been formed to suggest ways to improve the scores in the indicators where we are falling behind and advise the institute on what it may do to improve the ranking.

40.8 To report application status for NIRF Ranking

NIRF Ranking 2019 applications are out. We have started compiling the information. A committee comprising of Dr Richa, Dr Debajyoti and Dr Shobha is working on the detailed analysis of the data to be submitted.

40.9 To report list of students withdrawn/struck off from the rolls of the Institute in last Academic Year 2017-18.

A list of students withdrawn/struck off from the rolls of the institute in last Academic Year 2017-18 is placed at Annexure VI

40.10 To consider the nomination of members to Academic Senate (deferred item from previous meeting – Refer item no. 38.5)

UG RELATED MATTERS

40.11 To review the existing practice of making refund on withdrawal of admission by an Undergraduate student

Students who are finally admitted to B.Tech. programs through JAC are required to register and pay the balance fee. In the past it has been found that some candidates neither withdraw the admission within the stipulated time limit as per procedure specified in the JAC brochure nor report to the institute for registration by paying the balance fee. Consequently, the seat allotted to the candidate remains unfilled thereby causing loss of revenue to the institute, besides loss of opportunity to a deserving candidate, who could have utilized the seat.

Later on such candidates come forward with the request for refund of fee on one pretext or the other. The institute has not accepted their requests in the past but they keep on making repeated requests for refund. The matter was recently put up to the Admission committee (for Undergraduate programs) at its 2nd meeting held on 11th October,2018. While discussing the cases of refund of fee on withdrawal of admission the committee, interalia, recommended as under:

"Arising out of discussions the Committee recommended that existing practice of making refund on withdrawal of admission may be put up to Senate/BoG for review."

Accordingly it is submitted that the institute currently follows the procedure specified in the Information Brochure of JAC. As per existing procedure of Joint Admission Counseling (JAC) 2018, the candidates who wish to withdraw admission have to submit request within the specified date of withdrawal through JAC and the candidate will get refund as per section 6.2 in the information brochure mentioned below:

"Withdrawal of Allotted Seat and Refund of Fees

For withdrawal of admission, candidate is required to submit a request through JAC website ONLY.

- 1. Last date of withdrawal with a penalty of Rs.1000/- (Rupees One thousand only) is July 22, 2018 which is reporting date of last round of counseling (i.e. sixth round of counseling).
- 2. No request for withdrawal will be entertained after July 22, 2018.
- 3. Fee refunds for all withdrawals will be processed within 30 days after closing of admission process."

It is further mentioned that some of the candidates also make plea to refund the fee as per notification issued by University Grants Commission (UGC). The UGC vide its notification of December 2016 has, interalia, notified the following refund policy as per Clause 4.2.3 reproduced below:

"4.2.3 If a student chooses to withdraw from the program of study in which he/she is enrolled, the institution concerned shall follow the following four-tier system for the refund of fees remitted by the student.

Sr. No	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days before the formally-notified last date of admission
(2)	80%	Not more than 15 days after the formally-notified last date of admission
(3)	50%	More than 15 days but less than 30 days after formally-notified last date of admission
(4)	00%	More than 30 days after formally notified last date of admission

^{*(}Inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit)

- 4.2.4 In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 10% of the aggregate fees as processing charges from the refundable amount.
- 4.2.5 Fees shall be refunded by all HEIs to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard."

Senate is requested to review the existing procedure for refund of fee and make appropriate recommendation to the Board of Governors.

40.12 To consider whether admission to some seats of B.Tech(CSD) and B.Tech(CSSS) program in 2019 should be made through UCEED Rank and IIITD admission process respectively.

Admissions to some seats of B.Tech(CSD) were done through UCEED in 2017 and 2018. Though in 2017 the admission process was run by IIT Bombay, in 2018 IIT Bombay shared the list of students with us(for which we paid them Rs 3L) and the admission process was run by us.

Also, admission to some seats of B.Tech(CSSS) were done through IIITD admission process.

Below are the statistics for number of applications received and no. of students admitted in both the programs.

40.13 To consider whether Computer Networks and other courses listed in Sem 5 and 6 in regulations of various B.Tech programs to be included in 32 credits to be completed in last four semesters of B.Tech(CSE) program for completing graduation requirements.

The Senate at its 39th meeting held on 21st August,2018 considered the question of including Computer Networks (CSE Core course) in 32 credits to be completed in last four semesters of BTech (CSE) program for completing graduation requirements. The Senate had desired to re-visit the regulations/pre-requisites and work out a suitable proposal. While formulating the proposal the existing repeat rules and the concept of program electives may be kept in view. Thereafter, the proposal so formulated may be forwarded to Departments for further deliberations and for making appropriate recommendations for their respective programs.

desired the matter is being examined and the recommendations of the Departments will be placed before the Senate in the due course.

40.14 Allowing registration for substantially reduced credits (even only 4) in one of the semesters to B.Tech Students

The Senate at its 39th meeting held on 21st August,2018 considered the question of allowing registration for substantially reduced credits (even only 4) in one of the semesters to B.Tech Students and suggested that Departments may discuss this, and then give inputs to UGC to formulate a suitable policy. Below are the inputs received from various departments

CSE Department

- Allow underload only in the final semester only when core courses are finished.
- Policy should be consistent with UGC, AICTE, etc."

ECE Department

• Allow students to go for 6-months internship and during that period can register for a maximum of 4 credits (eg. IP/IS/Online courses etc.). (No internship credit is allowed.)

40.15 To consider the request of Mr. Veerander Kumar Jan to provide concession of one seat in B.Tech. and M.Tech. in all streams under Kashmiri Migrant Quota

Mr. Veerander Kumar Jan vide his letter dated 27.06.2018 has requested to provide concession of one seat in B.Tech. and M.Tech. in all streams under Kashmiri Migrant Quota. The matter was placed before the 2nd meeting of the UG Admission Committee,2018 held on 11.10.2018 After detailed deliberations the committee has recommended as under:

"To consider the request of Mr. Veerander Kumar Jan to provide concession of one seat in B.Tech. and M.Tech. in all streams under Kashmiri Migrant Quota. It was noted that at present, the Institute provides one supernumerary seat for admission in B.Tech. program under Kashmiri Migrant Quota. After detailed deliberations the Committee recommended that from next Academic year (2019-20) one seat in each B.Tech. program may be created on supernumerary basis for Kashmiri Migrant subject to acceptance of the same by the Senate/Board."

Senate may kindly consider and make appropriate recommendation to the Board.

40.16 To consider Admission Intake for B.Tech/M.Tech. programs for next Academic Year 2019-20

17 To consider Dual Degree Rules for B.Tech CS+X students

We currently have Dual Degree programs which allow students to do Dual Degree in M.Tech(CSE) and M.Tech(ECE). With new B.Tech programs added in last few year, we should decide about the criteria of allowing students of B.Tech CS+X programs to enroll for M.Tech(CSE) dual degree program.

4 To consider Criteria for admission of Foreign Nationals

In the 39th Senate, concern was raised regarding some of Foreign students facing challenges in understanding English. The Senate suggested understanding the criteria being followed by IITs. The criteria being followed by IITs will be placed on table.

40.19 Recommendation/Report by UGC

UGC in its 19th Meeting held on 19 Sep 2018 UGC discussed the matter of Grade policy for conversion of BTP to IP. The question whether Grade should be revaluated or same Grade has to be given or conversion process must be allowed only a month before presentations/grading. After detailed deliberations, it was decided that no BTP to IP conversion should be allowed. In case a student is incapable of completing the BTP, he must be given a Withdrawal (W) Grade.

Senate may kindly consider and approve the above recommendation.

40. Recommendation/Report by PGC

1. To consider recommendation of the PGC for giving waiver from TA duty for PhD students who are receiving Institute fellowship.

Senate in its 39th Meeting discussed the recommendation of the PGC made at its 30th meeting held on 09.07.2018 for giving waiver from TA duty for PhD students who are receiving Institute fellowship. After detailed deliberations the Senate agreed for grant of waiver for two semesters from TA duty to Ph.D. students who are on institute fellowship for the entire duration. The request for waiver will be considered after doing TA duty for 6 or 7 semesters. The students who are on RA ship are not to be considered for such waiver. The members of PGC, however raised a point that they are looking for a waiver from TA duty at any stage, to which the Senate requested the PGC to reconsider the recommendation and come up with a suitable proposal, as the student who is on Institute Fellowship initially might get shifted to RA ship later.

Mr. Abhishek, a candidate for admission to B.Tech. programs through JAC 2018 had filed a writ petition before the Hon'ble Delhi High Court vide No.WP(C) 7418/2018, against the Govt. of NCT of Delhi and others alleging denial of admission due to technical fault. After a number of hearings the said writ petition came up for hearing on 06.09.2018 and on the request of the counsel for the petitioner, the Hon'ble Delhi High Court granted leave to withdraw the present petition and dismissed the petition as withdrawn. **The matter therefore, stands closed.**

40.26 To report the status of Suit No.CJ/1151/2018, filed by AnimeshAttri in the court of Hon'ble Shri Gaurav Gupta, Civil Judge Junior Division-x, Civil Courts, Amritsar

A Civil Suit No.CJ/1151/2018 (Animesh Attri Vs. Delhi Technological University and Anr.), has been filed in the court of Hon'ble Shri Gaurav Gupta, Civil Judge Junior Division-x, Civil Courts, Amritsar, on behalf of Mr. Animesh Attri, JEE (Main) Roll

No.17302842, a candidate admitted to our B.Tech. (CSD) program with Roll No.2017280 through JAC 2017. Since Mr. Animesh Attri had neither paid the balance fee of Rs.60,000/- for first semester by 07.08.2017 nor reported for the classes, the seat allotted to him remained unutilised, thereby causing loss of revenue to the institute and wastage of a precious seat as the seat could not be offered to any other deserving candidate. Hence his request for refund of fee was not accepted. The above suit has been filed for recovery of Rs.70,000/- along with future interest @ 18%. The Institute has hired an Advocate to appear and defend our case; detailed reply to the petition opposing the claim has already been filed. The next date of hearing is fixed for 27.11.2018

THIRTY NINTH (39th) MEETING OF THE SENATE OF IIIT-DELHI (HELD ON 21st AUGUST, 2018)

MINUTES OF THE MEETING

General

39.1 Opening remarks of the Chairman.

The Chairman welcomed all to the meeting and introduced Prof. Ranjan Bose from IIT Delhi who will take over as Director of IIITD from 29th August,2018. He further informed that after his tenure is over on 28th August,2018 he will continue to be in the service of IIITD as a Distinguished Professor. All members and special invitees present at the meeting thanked the outgoing founding Director, Prof. Pankaj Jalote for his significant contributions in establishing and developing the new institute and successful completion of his two tenures. The members also welcomed Prof. Ranjan Bose and assured him full cooperation and support during his tenure. Thereafter, agenda items were taken up for discussions.

39.2 Confirmation of minutes of the 38th meeting of the Senate held on 11.07.2018

Since there were no comments, the minutes of the 38th meeting of the Senate held on 11.07.2018 were confirmed.

39.3 ACTION TAKEN REPORT

Chairman, Senate apprised the members of the action taken on the various decisions taken by the Senate at its 38th meeting of the Senate held on 11.07.2018. The Senate noted the position.

39.4 To report updated Academic calendar for Monsoon Semester 2018

The Senate approved the updated Academic Calendar for Monsoon Semester, 2018 placed at Appendix-1.

Action: HoDs/Academic Section

39.5 To ratify the approval given by the Chairman, BoG for creation of two extra seats in B.Tech program in Computer Science and Social Sciences (CSSS) to regularize the extra admissions made by JAC,2018 due to technical glitch.

Dr. Vikram Goyal, Chairperson UG Admission committee briefly apprised the members of some technical glitch found in implementing the guidelines for admissions through JAC,2018. The Senate noted/ratified the creation of two extra seats in B.Tech program in Computer Science and Social Sciences (CSSS) to regularize the extra admissions made by JAC,2018 due to technical glitch.

Action: Academic Section

39.6 To report the status of B.Tech. admission for Academic year 2018-19

Ms. Sheetu Ahuja, Manager (Academics) briefly apprised the members of the admissions made through various modes. She also answered the queries made by the members. It was noted that out of 422 admissions made through JAC, 2018 and other modes of admission only 416 candidates have finally joined and registered at IIITD. Final list of students admitted in AY2018-19 is placed at <u>Appendix-II</u>. After detailed deliberations it was decided that all students joining the institute shall be required to pay the balance fee and fill the joining and other essential forms like IT Policy and Honor code. All such candidates who fail to pay the balance fee and/or do not complete the joining formalities by the stipulated date shall be intimated immediately informing them of the cancellation of their admissions.

Arising out of discussions it was pointed out by some members that one of the new students admitted under ICCR scholarship scheme has difficulties in understanding English. After a brief discussion, the Senate desired to find the ways to help the student to overcome the difficulties being faced by the student. The selection process in future should have check points to ensure that students should have fair understanding about the medium of instruction of the institute and should be selected keeping in mind the above point.

Action: Academic Section

39.7 To report the status of M.Tech. admission for Academic year 2018-19

The Senate noted the position and desired that a meeting of all M.Tech. Admission Committee members may be organized soon to discuss the admissions related matters with a view to bring in further improvements.

Action: Academic Section

39.8 To report the status of Ph.D. admission for Academic year 2018-19

The Senate noted the position.

Action: Academic Section

39.9 To report status of application to NBA for Accreditation of B.Tech (ECE) program

The Senate noted the position.

Action: Academic

Sect

39.10 To report list of students completed graduation requirements on 21st May and

21st August 2018.

The Senate approved the award of degrees to the students who completed graduation requirements on 21st May and 21st August 2018, as detailed in <u>Appendix-III</u>

Action: Academic Section

39.11 To report list of students likely to complete graduation requirements on 21st December 2018.

Chairman Senate apprised the members of the background. The list of students expected to graduate in on 21st December, placed at <u>Appendix-IV</u> was noted, it was also noted that the number of students likely to graduate with December degree date are increasing every year. In the past some of the students who were allowed to attend the Convocation for photo opportunity were not able to complete the graduation requirement by 21st December for various reasons. After detailed deliberations the Senate desired that the matter may be discussed in the Student Senate, UGC and PGC whether the students likely to complete graduation requirement by 21st December may be allowed to attend the Convocation for photo opportunity. The Senate also desired that we should check as to what practice is being followed in peer institutes.

Action: Academic Section

39.12 To report recommendations for various Awards/Medals

The Senate ratified the award of Medals to the students mentioned in <u>Appendix-V</u>. The Senate further desired that for future years a brief summary may be submitted for each award/Medal. For this time a summary of all awards should be recorded in the minutes.

39.13 To ratify the decision taken by Chairman Senate for award of PhD Degree

Dr. Rahul Purandare apprised the members of the review reports and the comments made by all the three external examiners during thesis defence. After a brief discussion the Senate ratified the decision taken by the Chairman, Senate for award of Ph.D. degree to the following:

39.14 To discuss the proposal for allowing B.Tech students to do upto 2 extra credits of SG and CW each (deferred item from previous meeting- 37.18).

Consideration of this item was deferred to the next meeting.

Action: Academic Section

39.15 To discuss the proposal to convert grades for some courses to "S" in the First Year. (deferred item from previous meeting – Refer Item No. 37.19).

Consideration of this item was deferred to the next meeting.

Action: Academic Section

39.16 To consider whether it should be mandatory to do the core courses in their designated slots as per UG regulations for the UG students?

This item was dropped since there is no concept of slot.

39.17 (1) To consider whether Computer Networks (CSE Core course) to be included in 32 credits to be completed in last four semesters of BTech (CSE) program for completing graduation requirements.

Dr. Anubha Gupta, Chair UGC apprised the members of the background. After detailed deliberations, the Senate desired to re-visit the regulations/pre-requisites and work out a suitable proposal. While formulating the proposal the existing repeat rules and the concept of program electives may be kept in view. Thereafter, the proposal so formulated may be forwarded to Departments for further deliberations and for making appropriate recommendations for their respective programs.

Action: Academic Section/HoDs

(2) To consider a proposal for mandatory inclusion of additional Math course in BTech(CSE) graduation requirements.

Prof Pankaj Jalote, Chairman Senate apprised the members of the past discussions on this matter. After a brief discussion the Senate desired to find out the old minutes on this discussion and requested Department of CSE to discuss the matter and make appropriate recommendation to the UGC.

Action:Academic Section/HoDs

(3) To consider the Branch Transfer Rules for B.Tech. Computer Science and Biosciences

Chairman, Senate apprised the members of the background of the proposal and the branch transfer rules for other existing programs approved by the Senate at its 36th meeting held on 20.9.2017. After detailed deliberations the Senate desired that for transfer to CSB from other branches, student should have minimum grade "B" in "Introduction to Programing" and "Math I". Arising out of discussions it was also pointed out by some CSE faculty that for transfer to CSE SM grade should not be considered. The Senate suggested the matter to be taken up for discussion at department level and further recommendation to be made to Senate through UGC.

Action: Academic Section/HoDs

(4) To consider recommendation of the UGC/PGC for grant of medical leave to UG/PG students for availing the facility of the conduct of re-examinations of mid-sem and end-sem examination at a later date

Chairman, Senate apprised the members of the recommendations of the UGC/PGC for grant of medical leave to UG/PG students for availing the facility of the conduct of re-examination of mid-sem and/or end-sem examination at a later date. During the course of discussions it was noted that at present a number of students are submitting medical certificates from registered medical doctor to get exemption from the scheduled examination and request for re-examination at a later date. The number of such cases are increasing gradually. After detailed deliberations the Senate desired to examine the matter in detail by taking into consideration the practice prevailing at IIT Delhi to deal with such cases. Meanwhile, the students may be informed that only two medical applications would be accepted during the entire duration of their stay at IIIT Delhi for degree completion. Any request beyond this would be considered on case to case basis. Further, for grant of medical leave they will have to upload the medical certificate before the examination. They may also be told that the Institute reserves the right to get it examined for by Institute Doctor. Also, the request for medical leave will henceforth be approved by the Institute Doctor and not by the Dean.

(5) To consider recommendation of the UGC for grant of one month extension to BTech students to complete the project based courses (BTP / IP / IS / UR)

Chairman, Senate apprised the members of the recommendations of the UGC made at its meeting held on 6th August,2018 for grant of one month extension to BTech students to complete the project based courses (BTP / IP /IS / UR) started in any semester (Summer Term, Winter Semester, Monsoon Semester). After detailed deliberations the Senate agreed to the above recommendation of the UGC.

Action: Academic Section/HoDs

(6) To consider recommendation of the UGC for transfer of maximum number of credits for the courses done at other university.

Chairman, Senate apprised the members of the recommendations of the UGC made at its meeting held on 6th August,2018. After detailed deliberations, the Senate agreed to the recommendation of the UGC that if a student is spending a semester in some other university, and pursue some course, maximum 20 credits may be transferred to the credit pool of student's home institution. However, for the students going for exchange program upto one year, they can be allowed to transfer upto 40 credits to their credit pool.

Action : Academic Section

39.18 (1) To consider recommendation of the PGC for (i) conversion of MTech Thesis to Scholarly Paper and vice-versa and (ii) award of regular grades for thesis credits instead of 'S' or 'X'.

Chairman, Senate apprised the members of the recommendations of the PGC made at its 30th meeting held on 09.07.2018. After detailed deliberations the Senate requested the PGC to reconsider its recommendations for conversion from thesis to scholarly paper in the light of the discussions held at the meeting. The Senate agreed for award of regular grades for Thesis/SP credits however since Industrial Project is done with external supervisor, Senate requested PGC to suggest mechanism for awarding regular grades for Industrial Project instead of 'S' or 'X'.

Action: PGC, Academic Section

(2) To consider the revised rules recommended by PGC for doing the Industrial Project.

Chairman, Senate apprised the members of the recommendations of the PGC made at its 30th meeting held on 09.07.2018 for doing the Industrial Project. After detailed deliberations the Senate approved the following rules for doing Industrial Project:

The existing approved list shall no longer be valid for doing Ind Project.

- ii. For fresh listing of any company's name under the approved list for Indproject, the concerned company should give its profile and consent for guiding the student and submission of 6-10 pages report about the nature of project and the work done by the student during his/her internship duration at the company.
- iii. Companies and students are to be informed that the work done by the student is a public work and should clearly reflect in the report. NDA will not be applicable in such cases.
- iii. The Academic section will write to students with cc to Placement cell and PGC clearly informing them that, the student can do Ind Project only in the companies which are approved by PGC. In the event the Project is done in a company which is not approved by PGC, no credit will be given towards Ind Project.
- iv. If a student does a project in a company which is not in the approved list of PGC no credit shall be given for the Industrial Project.
- v. There shall also be a faculty guide from the institute for each Industrial Project. The grade shall be awarded by the IIITD faculty after seeing the report.

Action : HoDs/Academic Section

(3) To consider recommendation of the PGC for giving waiver from TA duty for PhD students who are receiving Institute fellowship.

Chairman, Senate apprised the members of the recommendations of the PGC made at its 30th meeting held on 09.07.2018 for giving waiver from TA duty for PhD students who are receiving Institute fellowship. After detailed deliberations the Senate agreed for grant of waiver for two semesters from TA duty to Ph.D. students who are on institute fellowship for the entire duration. The request for waiver will be considered after doing TA duty for 6 or 7 semesters. The students who are on RA ship are not to be considered for such waiver. The members of PGC, however raised a point that they are looking for a waiver from TA duty at any stage, to which the Senate requested the PGC to reconsider the recommendation and come up with a suitable proposal, as the student who is on Institute Fellowship initially might get shifted to RA ship later.

Action : PGC, Academic Section

(4) To consider recommendation of the PGC to award letter grades for MTech Thesis instead of 'S' or 'X'.

Discussed with point 39.18(1) above.

Action: HoDs/Academic Section

39.19 To consider a proposal for Encouraging women students to join IIIT-Delhi

Chairman, Senate apprised the members of the background of the proposal for Encouraging women students to join IIIT-Delhi. During the course of discussions it was noted that for admissions to BTech, the institute has the concept of bonus marks - which are granted for a host of achievements. From last year, IIITD has been granting some bonus marks to

Delhi students who are in 99th percentile of the CBSE. For the 99th percentile, the institute gets the cut-off from CBSE. They have indicated that they can give cutoffs separately for girls and boys. After detailed deliberations the Senate, in order to encourage/admit more girls, recommended to give bonus marks to boys who are in 99th percentile in CBSE among boys, and the same amount of bonus marks to girls who are in 98th percentile in CBSE. (Later, if this percentile does not achieve the desired effect, it can be further reduced.) This method will make more girls get admission in IIIT-D, without creating a "quota" for women (which many girl students oppose). It also aligns well with our approach for giving bonus marks. Further, the Chairman, Senate was authorized to take up the matter with the Board of Governors for approval. The Senate agrees to the final cut off (even if lower) to be decided by the Board.

Action: Academic Section

39.20 To consider nomination of members to Academic Senate . (deferred item from previous meeting – Refer Item No. 38.05).

Chairman, Senate apprised the members of the current tenure of the nominated members. After a brief discussion it was decided to defer the matter to the next meeting. However, till the nomination of new members are approved and notified, the Senate agreed to extend the existing tenure of the current nominated members.

Action : Academic Section

39.21 To report the status of Writ petition (WP (C) 7418/2018) filed by Mr. Abhishek, a candidate for admission to B.Tech. programs through JAC 2018

The Senate noted the current status of the Writ Petition.

Action : Academic Section

39.22 To consider the request of Mr. Udai Chopra (2012114) and Ms. Purnima (2012151) for grant of extension to complete the remaining credits for completion of degree requirement.

Chairman, Senate apprised the members of the request received from Mr. Udai Chopra(2012114) and Ms. Purnima (2012151) for grant of extension to complete the remaining credits for completion of degree requirement. After detailed deliberations the Senate agreed to their requests for extension with the following stipulations:

The Counselor may examine their requests and suggest the steps to be taken to monitor the progress of these students.

The students concerned should give and demonstrate plan as to how they will complete the remaining credits towards completion of degree requirements.

To consider inviting their parents to discuss and appraise them of the progress of their wards.

The Senate also recommended to to identify such students at an early stage. Following warning signals to be used to identify such cases: core courses left at the end of 6th Semester, considerably low SGPA/CGPA wrt the previous semester, more than one "F" grade in a particular semester. The Senate recommended doing regular academic counseling of such students and monitoring their progress throughout the semester. The Program Coordniators and HoDs should meet the students. Also the students should be brought in contact with the counselor. Regular performance monitoring report and the outcome of the interaction of such students to be reported to UGC/Senate. Also those who are unable to complete their graduation in 4 years, should be clearly informed that as stated in the regulations, no more than 6 years will be given to successfully graduate.

Action : Academic Section

39.23 To consider the request of Mr. Aman Verma for award of degree by considering the credits completed by him or allow him to migrate to dual degree by giving him exemption from CGPA requirement of 7.00

Chairman, Senate apprised the members of the request received from Mr. Aman Verma (2011015) for award of degree by considering the credits completed by him or allow him to migrate to dual degree by giving him exemption from CGPA requirement of 7.00. After detailed deliberations the Senate did not agree to his above requests. However, he was allowed extension with the stipulation that he has to complete his degree requirements in next one year based on the condition that no further extension will be given to him. Senate also suggested that student should submit a one year plan for his credit completion along with the undertaking singed by him and his parents for completing the credits in next one year.

Action: Academic Section

39.25 To consider certain regulation related issues for clarifications

Chairman, Senate apprised the members that with the new programs being added, the earlier regulations need some updations. After detailed deliberations it was decided to go through the regulations, identify such points and send to program coordinators with necessary clarifications. If the Coordinators are in agreement with the clarifications, the relevant regulations wherever necessary may be suitably modified with the prior approval of the Senate.

Action : Academic Section

39.26 To consider the issue of reduction of course contents for certain students

After conclusion of the discussions on the agenda points Dr. Pushpender Singh pointed out that some representative of the Student Senate has shared concerns and requesting to reduce the rigor of some of the courses. After detailed deliberations it was clarified that student representatives should not come forward with such requests. The concept of student representatives was earlier started to help the students who are unable to convey their point

to the Instructors, however since this is now being used by the students for a different purpose, the Senate suggested that SS should be informed about stopping the concept of Student Representatives and any student, if facing an issue with the course, should directly talk to the Instructor/Program Coordinator himself/herself.. DOAA was accordingly requested to send a suitable mail to the Student Senate..

Action: HoDs/Academic Section

The meeting ended with a vote of thanks to the Chair.







Page 3-4:

Eligibility and Admission Criteria: (Discipline-wise requirements)

Economics:

Application Eligibility:

M.A./MSc/MPhil in Economics, Statistics or Mathematics

BTech/MTech. in any discipline and/or MBA with strong interest in economics.

Entrance test and Interviews:

Eligible candidates will be invited to write an entrance examination that will test the candidate's foundational knowledge in intermediate economics.

Short-listed candidates from entrance exam stage will be interviewed by an expert committee and the final decision on the admission will be made based on the candidate's overall performance.

Candidates applying for PhD in Economics should submit a 2-page statement of purpose (SoP) delineating research theme(s) within Economics that may include specific questions of potential research interest to the candidate. The candidate is expected to clearly express his/her interestin theoutlined research theme(s) or questions to the extent possible.

Sociology/Anthropology:

Application Eligibility:

M.A./M.Sc./M.Phil.in Sociology, Anthropology, Political Science, Development Studies or any other related Social Sciences discipline.

MBA/MSW with a strong interest in Sociology/Anthropology

MTechwith a strong interest in Sociology/Anthropology

Need to have secured a minimum of 60% in their MA/M.Sc./MBA/MSW/MTech Preference will be given to those with a post-graduate degree in Sociology/Anthropology. Preference will also be given to those who have cleared either NET/JRF or SLET.

Entrance test and Interviews:

Eligible candidates will be invited to write an entrance examination that will test the candidate's knowledge in foundational Sociology and Anthropology topics.

Short-listed candidates from the entrance examination stage will be interviewed by an expert committee and the final decision on the admission will be made based on the candidate's overall performance.

Candidates applying for Ph.D. in Sociology/Anthropology should submit a 2-page statement of purpose (SoP) delineating research theme(s) within Sociology/Anthropology that may include

specific questions of potential research interest to the candidate when applying. The candidate is expected to clearly express his/her interestin theoutlined research theme(s) or questions to the extent possible.

Page 6:

Change from One Program to Another

The institute does not currently offer a Masters in any of the Social Science disciplines. Therefore, in scenarioswhere a student fails his or her comprehensive exam or the PhD thesis is not found suitable, migration to a different program is not possible.

Page 17:

Coursework requirement:

PhD students will be required to complete 32 credits of PhD level coursework, except for students who enter after an MPhil for whom some credits (no more than 8) may be waived. All courses are either 4-credit or 2-credit courses.

500-level courses (or higher) will be considered towards the PhD program. However, students may be allowed to take at most two advanced undergraduate courses (300-level or higher) with permission of PGC and thesupervisor.

Maximum of 2 Independent Study courses are allowed to be counted towards PhD credits. Independent Project credits are disallowed for PhD program in SS disciplines.

Till the number of on-campus PhD-level courses offered is greater than 8, any number of online courses may be allowed with permission of PGC and the supervisor.

Sociology/Anthropology: Specialized courseworkin addition to the general requirements above)

The students are expected to take two core courses - Research Methods in Sociology/Anthropology and Theories in Sociology/Anthropology worth 8 credits in total.

The total of 32 credits will be divided as 16 credits for Courses and 16 credits for PhD level research seminar style classes (where research papers are intensively discussed by the course instructor).

The students are encouraged to actively audit any related courses other than the expected for credit coursework.

Page 19:

Comprehensive Exam

Economics

Time limit for completion of comprehensive exam is 4 semesters, irrespective of the students' background, although in special cases one semester extension may be provided with permission

from the supervisor and PGC. Students with an MPhil degree may be considered for an earlier comprehensive exam.

Sociology/Anthropology

The students are expected to take their comprehensive examination at the end of the third semester. Time limit for completion of comprehensive examination is 4 semesters (maximum, with a maximum of four attempts) irrespective of the students' background, although in special cases one semester extension may be provided with permission from the supervisor and PGC.

Before the student finally defends his/her thesis for PhD in Sociology/Anthropology, the student is expected to have at least one research paper published in a well reputed national/international journal (recognized by UGC) and have at least one conference presentation at a well reputed national/international conference. In case of book chapters, the expectation is to have published them with well-reputed international publishers such as Sage/Wiley etc. The supervisor and the PGC will judge the nature and the prestige of the conference/book publishers.

Clarification notes:

Item 12.2 (p. 13) the CGPA requirement for continuing in the PhD program should be lowered.
