53.2 CONFIRMATION OF MINUTES OF THE 52nd MEETING OF THE SENATE

The Minutes of the 52nd meeting of the Senate held on October 04, 2021, placed at [Annexure-I](#), were circulated among the members. No comments have been received. The Senate may consider the same for confirmation.

53.4 ITEMS FOR INFORMATION/RATIFICATION

53.4.1 *General Matters*

53.4.1.1 To report the progress of the NAAC Self Study Report (SSR) submitted for Cycle 2 accreditation

SSR for Cycle 2 of NAAC accreditation was submitted successfully on April 7, 2021. Subsequently, as per the advice of NAAC, the payment of Rs.5.78 lakhs towards the visit has been made. The NAAC has now informed that their team will visit the Institute from 15-17 March, 2022

The above matter is reported for information of the Senate.

53.4.1.2 *To ratify the approval given by Chairman, Senate for inclusion of the name of Mr. Aman Gulia, (2017328) in the graduating list of 10th Convocation*

After the last convocation (i.e. 10th Convocation held on 16.10.2021) a case of Mr. Aman Gulia, (2017328), student of B.Tech. (CSSS) program came to our notice where the student had pointed out that he fulfilled the degree requirement but his name was not on the list of graduating students. The matter was thoroughly examined and it was found that he indeed fulfil the degree requirement, however, due to oversight of both student and admin (Ms. Prachi Mukherjee) his name was missed.

The case was put up to the Dean of Academic Affairs for his consideration and recommendation who has kindly recommended the case to Senate with a note to make sure that it does not happen again.

After considering the facts of the case the Chairman, Senate has kindly accorded his approval for inclusion of the name of Mr. Aman Gulia, (2017328) in the graduating list of 10th Convocation with degree date 21st September, 2021, with the advice to ensure that adequate checks are put in place so that such cases do not arise in the future. Keeping the same in view the existing process is being reviewed thoroughly to provide additional checks to avoid such instances in future.

The Senate is requested to ratify the approval given by the Chairman, Senate.

53.4.1.3 To ratify the approval given by Chairman, Senate for change of course for B.Tech. (CSB) from “Algorithm Design (B)” to “Analysis and Design of Algorithms (ADA)”

On the proposal of CSE and CB departments, recommended by DOAA, the Chairman, Senate has approved the change of course for B.Tech.(CSB) program from "Algorithm Design (B)" to "Analysis and Design of Algorithms" which is offered to B.Tech. (CSE) students. Since it is a change in the approved curriculum the change will be incorporated in the relevant regulations after ratification by the Senate.

The Senate is requested to ratify the approval given by the Chairman, Senate.

53.4.1.4 To ratify the approval given by Chairman, Senate for change of current guidelines as 'USD and equivalent' for payment of honorarium to external examiners

We have been making payment in USD to Ph.D. external examiners from abroad. We insist on transferring money in USD to Ph.D. examiners since that is how it got approved in Senate. This causes an unnecessary delay for examiners who do not live in the USA. The Chairman, Senate, on the recommendation of the DoAA, has kindly approved to change the current guidelines as 'USD and equivalent' for payment of honorarium to external examiners. There is no change in the amount approved etc. and it is only to be able to send payment to examiners (outside the US) in their local currency.

The Senate is requested to ratify the approval given by the Chairman, Senate.

53.4.1.5 To report the status of Suit No. CJ/1151/2018, filed by Animesh Attri in the court of Hon'ble Shri Gaurav Gupta, Civil Judge Junior Division-x, Civil Courts, Amritsar

The next date of hearing is scheduled for March 03, 2022.

53.4.1.9 To ratify the approval given by Chairman, Senate to the recommendation of the AAC for adding PIS (Prototyping Interactive Systems - DES206) and DIS (Design of Interactive Systems - DES205) course as an additional course in [Human Computer Interaction/TOC]# for the 2019 batch.

A request was received from the CSE department to consider PIS (Prototyping Interactive Systems - DES206) and DIS (Design of Interactive Systems - DES205) course as an additional course in [Human Computer Interaction/TOC]# for the 2019 batch.

From the 2020 batch, it is [Practical Bioinformatics/Prototyping Interactive Systems/Theory of Computation]#

The AAC agreed to the above recommendation of the CSE department and recommended for approval of the Senate over email.

Subsequently, considering the urgency the Chairman, Senate, on the recommendation of the Chair AAC and the DoAA, has approved for implementation of the above recommendation of the AAC.

The Senate is requested to approve and ratify the approval given by the Chairman, Senate.

53.4.1.10 To report the status of B.Tech. admissions for the Academic year 2021-22.

The B.Tech. Admission report is placed at [Annexure-III](#) for perusal. The list of admitted students with their allotted roll no is placed at [Annexure IV](#) for approval.

53.4.1.11 To report the status of M.Tech.(CB) admissions through DBT admission process for the Academic year 2021-22.

The M.Tech. Admission report for 2021 has already been reported in 52nd Meeting held on 04.10.2021 where it was informed that the result of M.Tech. (CB) admission through DBT is awaited. The same has now been completed and the following students 6 students out of 15 seats have been admitted to M.Tech. (CB) program w.e.f. December 13, 2021.

53.5 ITEMS FOR DISCUSSION AND CONSIDERATION

53.5.1 UG Matters

53.5.1.1 To consider the recommendation of the Academic Affairs Committee (AAC) for allowing the extension of another semester to Mr. Akash Nagrath (2015125), a UG student to enable him to complete the degree requirements.

The AAC at its 15th meeting held on September 30, 2021 considered the case of Mr. Akash Nagrath (2015125), a UG student for allowing him an extension of another semester to enable him to complete the degree requirements and observed/recommended as under:

“Chair AAC informed that Mr. Akash Nagrath (Roll No. 2015125), a repeater student of B.Tech. (ECE) 2015 batch, is currently in his 13th Semester (including the repeated year). He is left with 8 credits to complete the graduation requirements. He was allowed to register 12 credits in the Summer Term 2021, but due to certain circumstances (as stated by the student), he did not appear in the examination of one course of 4 credits, while out of the other two 4-credit courses, he has successfully cleared only one course. Hence, he is left with 8 credits to complete his graduation. After almost a month of starting the Monsoon 2021 semester, the student approached us to register in the current semester but his request for late registration has not been agreed to. However, he has been approved for the semester leave in the current semester. The HoD (ECE), after considering his case, has recommended that he may be allowed to register for the Winter 2022 semester along with appropriate warning/counselling. The AAC has considered his case and agreed to the above recommendation of the HoD (ECE) and recommended that he may be allowed another semester to complete the degree requirement with the warning that no further extension will be given to him. The AAC also suggested sending letters to the concerned students on completion of the 4th year so that they complete within a maximum of 6 years”.

The Senate is requested to consider and approve the above recommendation of the AAC.

53.5.1.2 To consider the recommendation of the Academic Affairs Committee (AAC) for allowing UG student with CGPA below 7.5 to register for IP/IS within the existing provision.

“A student may take “Independent Project” or “Independent Study” or “Undergraduate Research” courses for 1, 2, or 4 credits in a semester. No more than 8 of these credits can count towards the credit requirements of the degree. Only students with satisfactory CGPA (at least 7.5) or with a strong interest in some area (the faculty advisor to determine this) and with a CGPA of at least 7.0 can take these courses.”

The DoAA apprised the members of the background and informed them that there is a CGPA requirement for doing IP/IS in the B.Tech program, but there is no CGPA requirement for doing BTP. The AAC members deliberated on the matter and felt that IP / IS may give a hands-on experience to students. It may also boost the confidence of the students who are not able to perform well in the regular courses. In view of this, the AAC recommended that there should not be a CGPA requirement for doing IP/IS, and that the CGPA bar should be removed from the Academic year 2022-2023.

The Senate is requested to consider and approve the above recommendation of the AAC.

53.5.2 PG Matters

53.5.2.1 To consider the representation of Ms. Rupal Jain for the change of semester in the Provisional Certificate

Ms. Rupal Jain had joined B.Tech.(CSE) program in July 2015 and opted for a dual degree (B.Tech. and M.Tech. in CSE). Her B.Tech. program was completed in 2019 and effectively the M.Tech. part of dual degree program started from July, 2019. She has completed the requirement of M.Tech. (CSE) degree in Winter 2021 semester. Accordingly, she was issued a Provisional Certificate showing the completion of degree requirement with degree date of 21st June, 2021. Against this decision of the Institute, she made a representation dated September 10, 2021 wherein she raised several points and pointed out that there has been unfair change of semester in her graduation Provisional Certificate issued to her because she completed the degree requirement in Monsoon 2020 semester. The point raised by her were examined and a detailed reply was given to her vide letter No.IITD/Acad/2021/942 dated 20.09.2021 ([Annexure-V](#)). Not being satisfied with the reply given by the Institute, she has made another representation dated October 4, 2021([Annexure-VI](#)) wherein she has made similar points and requested not to shift the graduation date by 6 months as that will have a very bad impact on her career. In her representation dated October 4, 2021 she has also pointed out and submitted as under:

“As per your statement, the report was forwarded to Admin. M.Tech on 15.02.2021. The report submission to the administration is not a pre-requisite for graduating in Monsoon 2020 semester as per guidelines. It certainly should not be a basis for 6 month delay in my graduation date. Moreover, no guidelines stipulates about the shift of 6 months on the basis of report forwarding date to administration. The delay of one day beyond 21.02.2021 was caused due to the great sufferings of Covid-19 that my family and I were going through at that time. If you think it to be

appropriate, you may mention in my certificate that my graduation requirements were completed with the delay of one day i.e. 22.01.2021.

You may kindly appreciate that it is the duty of the Institute to schedule a viva voce, after ensuring that all the Rules/Regulations are followed before holding such a viva voce. It is unfair on the part of IIITD to expect from the students about ensuring that all rules/regulations are followed before scheduling a viva voce. When my viva was scheduled on 22.01.2021, I being a sincere and obedient student appeared in the viva voce on 22.01.2021. Since the viva voce (which is a final examination) was scheduled on 22.01.2021 with Administrative Lapse, therefore to save its face and fulfil the Administrative Lapses done by IIITD, the institute decided to schedule my viva voce again on 01.02.2021, which a harassment to me i.e asking me to appear again in the final exam (viva-voce) to fulfil the Administrative Lapses made on Institute's end.

Since the repeat Viva Voce on 01.02.2021 was done to fulfil the Administrative Lapse of IIITD, therefore the very same examiners were put in the repeat viva and as a sincere and obedient student, I fulfilled my duty by appearing again on viva voce on 01.02.2021. Since the repeat viva was again conducted to fulfil institutional lapses and with same examiners, therefore it is unfair for IIITD to penalise me for the lapses on their part. Hence the date of my defense should be considered as 22.01.2021 rather than 01.02.2021, as conducting repeat viva is neither my fault nor my responsibility. Rather, I fully cooperated with IIITD in all respects, despite of life-threatening conditions of my family and myself due to COVID-19.

I have already appealed to you, in my representation dated 10.09.2021 that in the interest of fair and just resolution of my grievances, my case may be put up before Senate and Board of Governors.”

It is submitted that the points raised by her in her representation dated October 04, 2021 are not based on facts and hence not tenable. The facts of the case and rules position already conveyed to her through Institute's reply dated 20.09.2021 are submitted below for perusal and consideration:

1. Ms. Rupal Jain was a dual degree B.Tech. and M.Tech. student from July 2019. She was given a waiver of 12 credits of bucket courses as per regulation. Her contention that she belongs to the M.Tech. batch of July 2018 in place of July 2019 as per letter dated 16.07.2018 is not correct. In fact Clause 4 of the offer letter dated 16.7.2018 given to her clearly mentions that “A dual degree student will be considered as a B.Tech. student till the time he/she completes the requirements of the same; thereafter he/she will be considered as an M.Tech. student. As per the transcript she completed the B.Tech. program in Winter 2019 and hence she has been correctly informed by the Institute that she was a dual degree B.Tech. and M.Tech. student from July, 2019.
2. As mentioned in para 2 of the Institute's reply dated 20.9.2021 she was allowed to change the M. Tech. Thesis Supervisor and also permitted to do the 16 credits of the Thesis work within one semester, i.e. Monsoon 2020 with an overload of 4 credits. This was

allowed to her as a special case despite the restriction of not allowing for students having CGPA below 8.00; her CGPA was less than 8.00. Despite this she has knowingly not mentioned of the permission given to her to change the supervisor as also the special permission to do 16 credits of the Thesis work in one semester, i.e. Monsoon 2020 with an overload of 4 credits. On the contrary she has pointed out that

“it was unjustly demanded of me to again earn fresh 16 credits of thesis in Monsoon 2020 because administration had unfairly nullified my previously gained 8 credits of thesis. Due to this, I had to request for 4 credits overload. Moreover, it is pertinent to note that I not only finished 20 credits of course requirements for Dual Degree but also finished 16 credits of M.Tech. Thesis by the Monsoon 2020 semester, and the grades for the said thesis credits were already forwarded by the Monsoon 2020 semester.”

Since she was allowed to change the supervisor on her request and **she had started the fresh thesis project under a new supervisor**, the credits earned by her under the previous supervisor cannot be counted for the new project.

It may be noted that she completed 20 credits of the course work requirements by the Monsoon 2020 semester. However, her thesis defense, an integral part of M.Tech., was pending. For the thesis, she was also required to successfully defend it to complete the graduation requirement as per the guidelines stated in the PG regulation point 15.4 reproduced below:

“(4) Thesis Option: Supervisor, Evaluation, and Defense

a. The M.Tech. thesis shall be done under the guidance of thesis supervisor(s), who shall be faculty member(s) of the Institute. A thesis may also have co-supervisors, who may be Adjunct Faculty of the Institute, or external co-supervisors approved by the PG Committee.

b. An M.Tech. thesis shall be evaluated by an evaluation committee which shall consist of the supervisor(s), including co-supervisors, and two other non-supervisor examiners. For a thesis, it is desirable to have one of the examiners from outside the Institute. The committee must be approved by the PG Committee.

c. The M.Tech. thesis must be defended by the student in front of the thesis evaluation committee. The defense should be held no earlier than one-week after the thesis has been submitted (exceptions may be granted by PG Committee Chair). The thesis evaluation committee shall make its recommendation to the PGC.”

3. The thesis defense guidelines were emailed to the faculty and the guidelines which are related to students are available on the Institute website (at [this link](#)). This was also discussed with all the students during interaction which was held every semester to guide about the processes like registration, graduation requirements etc. Her adviser was informed about this guideline over email dated November 05, 2019 separately, where she confirmed that she had understood the process and in response to which the advisor Dr. Sonia filled

the thesis defense request form on November 17, 2020 to hold the defense on 14th December 2020.

4. On 6th December 2020, Dr. Sonia requested DOAA to keep in abeyance the earlier proposed defense due to the family issue of the student due to COVID and requested DOAA to extend the thesis defense deadline and final thesis report submission date beyond 21st December 2020 which was the deadline for getting graduation date 21st January 2021. Here, both student and the advisor were well aware about the graduation date as well as the deadline notified by the Institute.

5. Looking at the situation of students due to COVID, DOAA had given permission till 31st December 2020 as the deadline, however she did not defend the thesis by that time and the advisor requested again to extend the deadline of defense and report submission upto 15th January 2021, which was also approved by Chair PG Affairs and DOAA. But she could not complete the thesis defense by the given date.

6. On 22nd January 2020, the Academic Section received an email from the advisor about the grade awarded to her after the thesis defense. The academic section had no prior information about the date of holding the thesis defense on 22nd January 2021, and no official notification was issued for the defense where all faculty and students are invited for the thesis defense. It may be noted that Dr. Sonia vide her email dated 22nd January 2021, has accepted this lapse and stated the student organized it at the last moment given the deadline of submission of the grades.

7. On receiving the grade, the Academic section pointed out to hold the defense as per guidelines. In response, the advisor vide email dated January 26, 2021 requested the Academic section to hold the defense on 1st of February 2021 with the same examiners proposed earlier. Thereafter, the Academic section after taking due approval for the examiners as per point/clause 15,4 (b) of the PG regulation and M.Tech. THESIS-SP-CapP Evaluation Process (<https://iiitd.ac.in/academics/resources>) organised the defense with due notification. The thesis defense was now properly conducted on February 1, 2021 and the Academic section received the thesis evaluation form from the Advisor on February 3, 2021. Immediately thereafter she was informed on the same day to submit the final thesis report which is a requirement for the award of degree. As per records she submitted the final report on February 15, 2021 which was approved by the Advisor on the same day. As she submitted the report on 15th February 2021, her graduation date is considered 21st June 2021 as per guidelines approved by the Senate. Each graduation date is linked to a semester in which the requirement is completed by the student. Even though she completed the course work requirement in the previous semester, i.e Monsoon 2020, she completed the degree requirement by successfully completing the thesis defense and by submitting the final report in Winter 2021. It may be noted that the transcript given to her earlier on her request was incomplete, where the following footnote is mentioned in the issued transcript; **"Graduation requirements for M. Tech. (CSE) is not yet completed"** whereas the final transcript contains the following footnote; **"Graduation requirements for M. Tech. (CSE) completed in Winter Semester 2021 (June 21, 2021)"**.

The Senate is requested to consider her representation in the light of the facts mentioned above.

53.5.2.2 To consider the recommendation of the Academic Affairs Committee (AAC) for making a minor change in the Internship guidelines of M.Tech. under “Collaborative Thesis with Industry or Academia/Guidelines for Collaborative Thesis

The AAC at its 15th meeting held on September 30, 2021 discussed a proposal from Associate Dean IRD regarding the impact of the proposal on collaborative research projects with Industry and observed/recommended as under:

“The Associate Dean IRD presented the proposal on collaborative research projects with Industry. The AAC discussed the proposal in detail and noted that this proposal can be implemented by making the following minor change in the Internship guidelines of M.Tech. under “Collaborative Thesis with Industry or Academia/Guidelines for Collaborative Thesis”:

(b)Such students should take necessary approvals from the advisor and the academic office before starting their work. The student has to submit the approval of the supervisor to the academic office at least one week before the list of eligible students for internship +FT offer is submitted to the Placement Office so that they can be excluded from this list.”

The Senate is requested to consider the above recommendation of the AAC.

53.5.2.3 To consider the recommendation of the Academic Affairs Committee (AAC) for starting M.Tech. (CB) Dual Degree program.

The Academic Affairs Committee (AAC), in its 17th meeting held on January 26, 2022, considered a proposal for starting a Dual Degree program in M.Tech. (Computational Biology). Dr. Ganesh Bagler and Dr. K. Sriram presented and explained the salient features of the proposal, and answered the queries. After detailed deliberations, the AAC agreed to the proposed regulations with minor changes, placed as [Annexure IX](#), and recommended the same for approval of the Senate.

The Senate is requested to consider the above recommendation of the AAC.

53.5.2.4 To consider the recommendation of the Academic Affairs Committee (AAC) Course credit requirements for Mr. Vishal Kumar as per current Ph.D. regulations.

AAC noted that Mr. Vishal Kumar has done B.Tech. and M.Sc. in Computer Science (from Cochin University of Science & Technology). During the course of discussions, it was felt that the Ph.D. coursework requirement for such students should be the same as that for Ph.D. students admitted with an M.Tech. degree. The AAC recommended 16 credits of Ph.D. coursework for students admitted with 4 years of B.Tech. and 2 years of M.Sc.

The Senate is requested to consider the above recommendation of the AAC.

53.5.3 Other Matters

53.5.3.1 To consider the draft of the PG Diploma Certificate

Currently, we are offering two diplomas, one in collaboration with IBM and the other in collaboration with Great Learning. A copy of the initial draft of the Diploma certificate is available in [Annexure VII](#). For seeking suggestions the said draft certificate was shared with the Committee which had looked into the design of Degrees/certificates awarded in the 10th Convocation. The Committee has considered and recommended the above draft format for approval. It has also been decided not to mention the company's name on the Diploma certificate. The same practice is being followed by other academic institutes (such as IIT-B) offering diplomas in collaboration with industries.

Senate is requested to consider and approve the format of the PG Diploma certificate recommended by the Committee.

53.5.3.2 To consider the list of students who have completed graduation requirements on 21st January 2022.

The list students who have completed graduation requirements on 21st January 2022 will be placed on the table.

53.5.3.3 To consider the End of Semester Summary Report (Monsoon 2021)

A summary of various activities of academics undertaken in the previous semester (Monsoon 2021), including the performance of UG/PG/Ph.D., will be placed on table.

53.5.3.4 To consider the recommendation of the Academic Affairs Committee (AAC) to allow PGDDS&AI students to clear their Backlog to get the Diploma

Following PGDDA&AI students were not able to complete a few of their courses due to the ongoing pandemics. With the request of students, a committee consisting of Prof. Vikram Goyal (Project Director), Dr. Debarka, and Anuka Kumar (IBM) looked into their cases and recommended that they may be given another chance to complete their program looking at the current pandemic situation.

AAC discussed the matter and recommended allowing these students with a fine of Rs.2500/- per credit i.e. for two credits course the fine is Rs.5,000/-

The Senate is requested to consider the above recommendation of the AAC.

53.5.3.5 To consider the recommendation of the Academic Affairs Committee (AAC) to establish Alumni Awards at the Institute.

The proposal was presented to AAC by Dr. Paro Mishra (Associate Dean, Communication and Alumni Affairs) for establishing Alumni Awards to recognize the outstanding accomplishments and achievements of IIIT-Delhi alumni who are making a difference in the world through their professional and/or academic achievements, or through their significant contributions to the community. She explained the salient features of the proposal. Dr. Ganesh Bagler (former ADoCA) was present at the meeting and also clarified the points raised by the members. After detailed deliberations, the AAC agreed to the proposal placed as [Annexure-X](#) and recommended the same to the Senate for approval. The institute will honor the recipients of the awards on the 'Foundation Day' of IIIT-Delhi.

During the course of meeting, some of the AAC members also discussed and suggested that apart from certificates, a medal/memento/plaque bearing the title of the award, name of the awardee, year, etc. should also be given to honor the recipients of the awards. The suggestion was approved by the AAC.

The Senate is requested to consider the above recommendation of the AAC.

53.5.3.6 To consider List of Experts for Faculty Selection Committees.

As a process the existing list of the Faculty Selection Committee Experts is augmented in some interval of time and the list is placed before the Senate for consideration. Accordingly the detailed list will be placed on the table.

53.5.3.7 To consider the guidelines for non-degree/professional candidates from industry to attend regular courses offered at IIIT-Delhi.

In the 15th AAC meeting held on September 30, 2021, the AAC Chair apprised the members of a recent request received from the Department of ECE about offering a course to industry folks. It was noted that currently, we have a provision for this, where a candidate pays Rs. 8000/- per credit along with Rs.5000/- as security. But a formal approach may be adopted to regularize the process. During the discussion, it was suggested that this fee amount should be in accordance with the B.Tech. fee. Currently, the institute charges a fee of Rs. 10,000/- (approx.) per credit from the B.Tech. students (the annual fee for the B.Tech. program is approximately Rs. 4 lakhs and the B.Tech. students are required to do 20 credits per semester). The AAC recommended a fee of Rs. 10,000/- per credit and a refundable security deposit of Rs.10,000/-. This fee will get automatically revised if there is a revision in the B.Tech. fee. This will be adopted for all professional candidates, i.e., non-degree visiting students and industry folks. A transcript will be issued to all registered candidates in a format similar to that of the transcripts issued to our regular students. Mr. K. P. Singh mentioned that we already have guidelines for the registration of professional candidates. The AAC desired to review these guidelines in the upcoming AAC meeting.

In the 17th meeting, the AAC discussed existing guidelines for Professional Candidates Registration (PCR) in regular courses at IIIT-Delhi. It was noted that as per the existing

guidelines, a Certificate of satisfactory completion of a course will be issued to only those candidates who have received at least a 'C-' grade in the course. However, according to our metric, the letter grade 'C' is equivalent to satisfactory performance, so the AAC recommended issuing this certificate to only those candidates who have received at least a 'C' grade (instead of a 'C-' grade) in the course. The AAC also recommended issuing a transcript mentioning the name of the course, the number of credits and the grade received to all the registered candidates after completion of the course. The AAC had already recommended a fee revision in the 15th meeting. Except for the above-mentioned points, the AAC agreed with the remaining guidelines.

The revised rules for Professional Candidates Registration (PCR) are placed as [Annexure VIII](#) for approval of the Senate and the Finance Committee.

Arising out of the discussion, the AAC recommended that henceforth, the cases of Professional candidates will be dealt with by the Academic Section. The advertisement for the course(s) will be made through the website and social media. Besides, wherever necessary, the academic section will seek support from the Placement and Alumni divisions. The list of companies prepared for the Industrial Doctoral Program should also be used for publicity purposes.

The Senate is requested to consider the above recommendation of the AAC.

53.5.3.8 To report admission of Pulkit Nargotra to B.Tech. (CSAM) through JAC 2021 and award of PMSSS scholarship, Academic Year 2021-22, on his own.

For Pulkit Nargotra admitted to B.Tech. (CSAM) through JAC 2021, we have received an allotment letter, F.No. J&KSSS/2021-22/ Couns/2021319509 from AICTE under Prime Minister's Special Scholarship Scheme (PMSSS).

It may be noted that the admissions on the basis of PMSSS (supernumerary) were not undertaken last year on the directions of the Board as the fee compensated by the AICTE was lesser than the fee charged by the Institute. However, in the present case, the admission has been made through the JAC and PMSSS is just financial support. It can be considered favourably provided the student pays the complete fee upfront under an undertaking clearly spelling that he will continue to pay the full fee to the Institute irrespective of the payments/support under the PMSSS. In case the PMSSS money directly comes to the Institute, the same can be refunded to him.

In view of the above it is proposed to facilitate the student to receive the PMSSS scholarship from AICTE by taking an undertaking from him to the effect that he will continue to pay the full fee to the Institute irrespective of the payments/support under the PMSSS.

The above proposal is submitted to the Senate for approval and necessary direction towards reporting to the Board

53.5.3.9 To consider the recommendation of the Academic Affairs Committee (AAC) to allow faculty of IIT-Delhi to Teach in sister institutes like IITs/NITs/ISIs/ etc.

The Dean of Academic Affairs apprised faculty members and the institute have been receiving requests for supporting their teaching. The DoAA informed that such engagements with reputed institutes like IITs/ISI/NIT, etc. will enhance the reputation of the Institute and will also provide opportunities for faculty members whose courses are not covered by on-line diplomas. Earlier such requests were not approved, because beyond institute teaching, the faculty members were expected to engage in research activities only. However, recently, the institute has already allowed faculty members to take up additional teaching assignments for PG Diplomas. However, the PG Diplomas only cover a few courses and leave other courses while such requests require faculty for a wider range of courses. Therefore, the same needs to be allowed under the consultancy hours. The matter was also discussed with the Director in the Dean's meeting and he has agreed to it, in principle, and desired that the matter may be discussed in the AAC for a policy decision.

Thereafter, the AAC discussed the matter in detail and agreed to the proposal and suggested the following:

Faculty needs to inform the institute about such requests and provide the following relevant information:

- Name of the institute and location.
- Number of teaching hours required
- Duration of teaching, i.e., the start date and the end date of the teaching assignment
- Mode of teaching (online or physical classes)
- Will the instructor be required to visit the institute? If yes, then for how many days?
- Number of students in the course
- TA support provided by the inviting institute
- Evaluation/Exam support provided by the inviting institute
- Financial information
- Any other information deemed important.

The academic section should create a form with the above information, which the faculty would have to fill.

- The approval needs to be taken from DoAA & DIRD.
- Rules for undertaking the teaching work will be similar to the Consultancy Rules. A form may be prepared to collect this information.
- For any such teaching activities, no additional support, e.g. TA support will be provided from IIT-Delhi. So, either the concerned faculty should ask for TA Support from the inviting Institute for evaluation work or he/she should manage on his/her/their own.
- Online Teaching can be permitted for institutes located anywhere in India. However, the offline teaching (physically taking classes) of such courses will be limited to Delhi – NCR based Institutes only. Further, if any local travel is required, no additional leaves will be provided and faculty will have to manage within existing

leave rules, i.e., casual or earned leave. Such activities will not be provided “Work leave”.

MINUTES OF THE MEETING

47.1 52.1 WELCOME AND OPENING REMARKS BY THE CHAIRPERSON

At the outset, the Chairman, Senate welcomed all to the 52nd meeting of the Senate. Thereafter, he requested the Dean of Academic Affairs to present the agenda items.

52.2 CONFIRMATION OF MINUTES OF THE 51ST MEETING OF THE SENATE

The Dean of Academic Affairs informed that no comments were received on the Minutes of the 51st meeting of the Senate held on August 11, 2021. The Senate, therefore, confirmed the Minutes of the 51st meeting as circulated.

Action: Academic Section

52.3 ACTION TAKEN REPORT

The Dean of Academic Affairs apprised the members of the action taken on the various decisions taken by the Senate in its 51st meeting held on August 11, 2021. The Senate noted the position.

52.4 ITEMS FOR INFORMATION/ RATIFICATION

52.4.1 General Matters

52.4.1.1 To report the progress of the NAAC Self Study Report (SSR) submitted for Cycle 2 accreditation

The Dean Academic Affairs informed that due to the COVID-19 lockdown, the NAAC had given the Institute an extension to submit the SSR for Cycle 2 accreditation. Accordingly, the SSR has been submitted on April 7, 2021. Subsequently, some clarifications were sought via the NAAC portal, for which all the documents have been submitted on June 30, 2021. The NAAC team will soon notify the next steps. The Senate noted the position.

Action: Academic Section

52.4.1.1.2 To report recommendations for various awards and medals to be awarded in the 10th Convocation to be held in virtual mode

The Dean Academic Affairs apprised the members of the recommendations for various awards and medals based on CGPA for the 2021 graduating batch. It was noted that the Senate in its 51st meeting held on August 11, 2021 had already approved the All Round Performance Medals. He also informed that due to Covid-19, there would be no award for BTP and best M.Tech. Thesis award this year. Further, it was noted that the **Institute Silver Medals** will be awarded in the 10th Convocation for the first time.

Further, the DoAA informed that a new award “**Doctoral Dissertation Award**” has been introduced from the current year. Based on the majority votes of the external examiners a total of 17 Ph.D. students who will be receiving degrees in the 10th convocation will be given the Doctoral Dissertation Awards. During the course of discussion it was felt that the number of awardees appear to be on the higher side and hence there is need to review the guidelines in order to restrict the number of awardees for the next year. The DoAA also suggested that recommendation for award by all the three external examiners (instead of two out of three) may bring the number down to some extent. After detailed deliberations the Senate agreed to the proposal for the various medals and awards detailed in [Appendix-I](#), to be given in the 10th Convocation and recommended the same for approval of the Board of Governors. The Senate also desired to review the guidelines for Doctoral Dissertation Award in the AAC for appropriate recommendation for the next year.

52.4.1.1.3 To report the status of suit No. CJ/1151/2018, filed by AnimeshAttri in the court of Hon'ble Shri Gaurav Gupta, Civil Judge Junior Division-x, Civil Courts, Amritsar

The Senate noted the position.

52.4.1.1.4 To report the status of suit No. CS SCJ/116/19, filed by Nikhil Gautam in the court of Hon'ble Shri Sushil Anuj Tyagi, JSCC-cum-Addl. SCJ-cum- Guardian Judge, South East, Saket, District Court, New Delhi

The Senate noted the position.

52.4.1.1.5 To report the status of Compliance Affidavit filed by the Institute in the matter of Courts on its Motion in re: Suicide Committed by Sushant Rohilla, Law Student of I.P. University (W.P.(CRL) 793/2017)

The Senate noted the position.

52.4.1.1.6 To report the status of Ph.D./M.Tech. (CSE, ECE and CB) admissions for Academic Year 2021-22

The Dean Academic Affairs apprised the members of the recently completed Admission to M.Tech. and Ph.D. programs for Academic year 2021-22, following the Academic Calendar and the process of the regulations of the respective courses. The highlights of the various admission related data was presented through slides. It was informed that seats from DBT for M.Tech. (CB) are yet to be filled. During the course of discussion it was also informed that number of applications for Ph.D. admission has decreased in the past and hence efforts will be made to visit some of the colleges to interact with the faculty and the prospective candidates with a view to increase the number. The Director (Chairman, Senate) also added that this has been an ongoing discussion both at the Departments level and in the Heads' committee meetings, as to how to improve the quality of PG students and also increase the catchment areas. He also welcomed the suggestions from the Senate members in this regard. After detailed deliberations the Senate accepted the newly admitted students to various programs mentioned [Appendix-II \(M.Tech.\)](#) & [III \(Ph.D\)](#) and recommended the same for approval of the Board of Governors.

52.4.1.1.7 To ratify the approval given by the Chairman, Senate for Academic Calendar for Winter 2022

The Dean Academic Affairs presented the Academic Calendar for Winter 2022 (PG and UG students 2nd year onwards) approved by the Chairman, Senate. He also informed that the ongoing (Monsoon 2021) semester for UG Senior (5th Semester onwards) and PG will end on 13th December, 2021. He further informed that we are running parallel semester for the UG students admitted in 2020. For them the 3rd semester which started on 20th September will end on 31st December, 2021. For the new UG students which we will admit in November/December the 1st Semester will start on 3rd January, 2022 and end on 13th April, 2022; their 2nd Semester will start on 25th April, 2022 and will go upto 4th August, 2022. By this time, if everything goes well i.e. if there is no Corona, we will have a common calendar for all the batches starting from 29th August, 2022.

After detailed deliberations the Senate ratified the approval given by the Chairman, Senate to the Academic Calendar for Winter 2022 placed at [Appendix-IV](#).

52.5 ITEMS FOR DISCUSSION AND CONSIDERATION

52.5.1 UG Matters

52.5.1.1.1 To consider the promotion rules applicable for the promotion of UG students from the first year to the second year.

The Dean Academic Affairs apprised the members of the background of the proposal and informed that the above matter was discussed in 14th AAC held on 22nd July,2021 where the AAC made the following recommendation to Senate for consideration:

“The Repeat and termination clause mentioned in point 7.1 in UG regulation is to be updated as under:

“For repeating 1st year

If a student fails in any 5 or more courses after completing 1st year, i.e., 1st and 2nd regular semesters (excluding summer), provided he/she did not take semester leave in any of the two semesters, then he/she will have to repeat the year.”

It was also discussed not to have a separate termination clause for the first year, they will be given a chance to continue, however the termination clause (7.3 clause of UG regulation) which is applicable to 2nd, 3rd, and 4th year was recommended to be also applied to the students who have repeated 1st year”.

To a query made by the members the DoAA clarified that in order to help the students to improve their performance in the 2nd semester the new rule has been proposed to be simpler. After detailed deliberations the Senate approved the above recommendation of the AAC.

51.5.2 PG Matters

None.

51.5.3 Other matters

52.5.3.1.1 To consider the list of students who have completed graduation requirements and elibigle for degrees in Convocation 2021.

The Dean Academic Affairs informed the members that the students who have completed Graduation requirement on 21st January, 2021, 21st June,2021 and 21st September,2021 are eligible for the award of degrees in the 10th Convocation of the Institute. The final list of **576** graduating students, detailed below, is placed for consideration and approval of the Senate.

Sub: Representation against an unfair change of semester in graduation provisional certificate

Dear Ms. Jain,

I have been shared your email and directed to look into it and respond to you. I have called for the records and have examined the case in the light of your representation. While I truly sympathise with the difficulties faced by you and your family due to COVID-19, the Institute is bound by its rules and regulations even in these difficult times. To the extent that any relaxation could be given to you, the same were in fact given, which would be seen from the following.

1. As a dual degree B.Tech. and M.Tech. student from July 2019, you were given a waiver of 12 credits of bucket courses as per the PG Regulations. However, you were required to complete 20 credits of Course Work and 16 credits of Thesis Work as per rules. For the M.Tech. Thesis work, you were also required to successfully defend it and submit your thesis report to complete the graduation requirement as per clause 15.4 of the Guidelines of the PG Regulations.
2. On your request, you were allowed to change the M.Tech. Thesis Supervisor and also permitted to do the 16 credits of the Thesis work within one semester, i.e. Monsoon 2020 with an overload of 4 credits. This was allowed to you as a special case despite the restriction of not allowing for students having CGPA below 8.00 and your CGPA was less than 8.00. You completed 20 credits of the Course Work requirements by the Monsoon 2020 semester. However, your thesis defense, an integral part of your M. Tech, was pending.
3. The thesis defense guidelines as stipulated in the M.Tech. THESIS-SP-CapP Evaluation Process were emailed to the faculty and the guidelines which are related to students are available on the Institute website (<https://iiitd.ac.in/academics/resources>). This was also discussed with all the students during the interaction held every semester to guide them about the academic processes like registration, graduation requirements etc.
4. Your Thesis Supervisor/Advisor, Dr. Sonia Baloni was informed about thesis guidelines over email dated November 05, 2020 separately, where she also confirmed that she had understood the process and in response to which the Advisor, Dr. Sonia filed the thesis defense request form on November 17, 2020 to hold the defense on December 14, 2020.

5. However, on December 6, 2020, Dr. Baloni requested the Dean (Academic Affairs), DOAA, to keep in abeyance the earlier proposed defense due to some issues in your family due to COVID and requested the DOAA to extend the thesis defense deadline and final thesis report submission beyond the last date, i.e. December 21, 2020 the deadline for meeting the Degree Granting Date / Graduation Date of January 21, 2021.
6. Please note that both you and your Advisor were well aware about the Graduation Date as well as the deadline notified by the Institute. Looking at your situation due to COVID, the DOAA had given permission till December 31, 2020 as the deadline, however you did not defend the thesis by that time and the Advisor made another request to extend the deadline of defense and report submission upto January 15, 2021; this was also approved by Chair (PG Affairs) and DOAA, as a special case. The deadline of January 21, 2021 being the Graduation Date cannot be extended and is required to be adhered to on account of the decisions and rules framed by the Senate of the Institute, which has the approval of the Board of Governors. It is thus evident that the DOAA accommodated your request to the maximum extent possible. However, you could not complete the thesis defense by the given extended date, nor was the report submitted.
7. On January 22, 2021, the Academic section received an email from the Advisor about the grade awarded to you after the thesis defense which had been conducted on that same day. However, the rules on the subject are clear and require that prior information has to be given to the Academic section, so that the processes of the Institute are followed. I have also examined your contention regarding a public versus a private thesis defense and you may please note that in the Institute, there is only one type of thesis defense, i.e. a public defense; this is one of the primary reasons for giving prior information to the Institute. It is evident that in her anxiety to come to your assistance, the Advisor may have sympathetically organized your thesis defense without following the Institute's processes, for which she has since regretted.
8. In any event, the grade awarded to you in the above manner on January 22, 2021 could not be counted towards your graduation within that Semester. Apart from being conducted contrary to the notified rules/guidelines, it was also beyond the extended time granted to you for thesis defense and report submission, which expired on January 15, 2021, as also the Graduation Date (January 21, 2021). Moreover, on January 22, 2021, the Monsoon Semester had ended and the Winter Semester had started.
9. The Academic section was not given any prior information about the date of holding the thesis defense on January 22, 2021, and no Official Notification was issued for the defense where all faculty and students are invited for the thesis defense. From the information received from the Advisor it was learnt that the defense had been organized at the last moment, in a manner which was against the rules/guidelines notified by the Institute.
10. On receiving the grade, the Academic section immediately pointed out the shortcoming and requested to hold the defense as per guidelines. In response thereto the Advisor vide email dated January 26, 2021 requested the Academic section to hold the defense on February 1, 2021 with the same examiners proposed earlier. Thereafter, the Academic section after taking



due approval for the examiners as per point/clause 15.4(b) of the PG Regulation and M.Tech. THESIS-SP-CapP Evaluation Process (<https://iiitd.ac.in/academics/resources>) organised the defense with due notification. The thesis defense was now properly conducted on February 1, 2021 and the Academic section received the thesis evaluation form from the Advisor on February 3, 2021. Immediately thereafter you were informed on the same day to submit the final thesis report which is a requirement for the award of degree. As per records you submitted the final report on February 15, 2021 which was approved by the Advisor on the same day.

11. As you submitted the report on February 15, 2021, your Graduation Date will be June 21, 2021 as per guidelines approved by the Senate. Please note that each Graduation Date is linked to the semester in which the requirements are properly and fully completed by the student. Even though the Course Work requirements may have been completed by you in the Monsoon 2020 semester, the remaining necessary requirements towards the award of the degree (including public defense of the thesis and submitting the final report) were accomplished by you only during the Winter 2021 semester. The transcript given to you on your request was incomplete, as could be seen from the footnote which mentions that the "Graduation requirements for M.Tech. (CSE) is not yet completed". When the final transcript will be issued after the Convocation, the current status will then be changed to "completed" and the final transcript to be issued along with the degree will contain the following footnote; "Graduation requirements for M.Tech. (CSE) completed in Winter Semester 2021 (June 21, 2021)".
12. The Institute tries to help all its students achieve their maximum potential to the greatest extent possible. Even in your case the requests for change of Advisor, overload, extensions have been allowed keeping in view your requests and the prevailing COVID conditions etc. However, relaxations and extensions are not permissible beyond a point, and a balance has to be struck between helping our students and maintaining academic standards and discipline.
13. Having examined your case in detail, I am clear that there is no unfair change of semester and you have been correctly issued the provisional certificate as you completed all the graduation requirements only in the Winter Semester 2021. The final transcript and degree shall be awarded to you as indicated above.

Subject:-Representation against an unfair change of semester in my graduation Provisional Certificate.

Respected Sir,

With reference to your response dated 20.09.2021 in connection with my representation, I want to submit the following for your kind consideration. The paragraph-wise reply to your response is as under-

1. It is incorrect to say that I am a Student of Dual degree (B.Tech and M.Tech) in the batch of July 2019. I belong to the MTech batch of July 2018 in place of July 2019 as is evident from the File No. IIITD/ACAD/Dual Degree/2018/576 dated 16.07.2018. It is also not true that I was given a waiver, it was provided to every Dual Degree student as already stated in the Dual Degree guidelines.
2. The reasoning mentioned in para 2 is incorrect. I am a student of M.Tech 2018 batch. These new rules as you have stated do not apply to me. It was unjustly demanded of me to again earn fresh 16 credits of thesis in Monsoon 2020 because administration had unfairly nullified my previously gained 8 credits of thesis. Due to this, I had to request for 4 credits overload. Moreover, it is pertinent to note that I not only finished 20 credits of course requirements for Dual Degree but also finished 16 credits of MTech Thesis by the Monsoon 2020 semester, and the grades for the said thesis credits were already forwarded by the Monsoon 2020 semester.
3. The reply in para 3 is incorrect. There was absolutely no responsible and formal intimation to students about the compulsory public MTech defense. Hence, I should not be compelled to bear the consequences of this institutional lapse.
4. I am not privy to any conversation that might have happened between the administration and faculty. More importantly, there was no mention of

public defense anywhere in the guidelines applicable to Dual Degree M.Tech 2018 batch.

5. It is correct that me and my family were going through the grave sufferings of Covid-19 at that time.
6. I finished all my credit requirements for graduation in Monsoon 2020 semester and finished my MTech thesis defense on 22.02.2021. It would be nothing but fair to state my actual date of completion of credits and graduation requirements i.e. 22.01.2021 in my degree and provisional certificate.
7. I should not be compelled to bear the repercussions of this institutional lapse, keeping in mind the sufferings of Covid-19 with me and my family at that time.
8. Despite still struggling with possibly the worst impact of COVID-19 in my life at the time, as a responsible and hard working student, I did my part by finishing all my credits requirements in Monsoon 2020 semester and by defending my thesis on 22.01.2021. I am only requesting you to not shift my graduation date by 6 months as that will have a very bad impact on my career.
9. As a student, I successfully fulfilled my responsibility to present my thesis and receive evaluation from my Advisor and two approved Examiners.
10. Administration informed my Advisor about a public defense after the defense had already been conducted on 22.01.2021. Despite this major failure at your end, I and my Advisor made great attempts to schedule a repeat defense on 23.01.2021 itself. However, Admin M.Tech turned down my request to send a public invitation for 23.01.2021. Various e-mail exchanges with administration show that my Advisor and I went through a great deal of trouble to conduct a repeat defense. It is also incorrectly mentioned that the Academic Section took the approval for Examiners on 26.01.2021. My Advisor had already received the approval for my Examiners (Prof. Anubha Gupta and Prof. Mrinmoy Chakraborty) well in Advance in December 2020.

11. As per your statement, the report was forwarded to Admin. M.Tech on 15.02.2021. The report submission to the administration is not a prerequisite for graduating in Monsoon 2020 semester as per guidelines. It certainly should not be a basis for 6 month delay in my graduation date. Moreover, no guidelines stipulates about the shift of 6 months on the basis of report forwarding date to administration. The delay of one day beyond 21.02.2021 was caused due to the great sufferings of Covid-19 that my family and I were going through at that time. If you think it to be appropriate, you may mention in my certificate that my graduation requirements were completed with the delay of one day i.e. 22.01.2021.
12. It is a general statement and I do not want to express my opinion on this.
13. It is a grave injustice to me, keeping in view the known sufferings of Covid-19 with me and my family.

You may kindly appreciate that it is the duty of the Institute to schedule a viva voce, after ensuring that all the Rules/Regulations are followed before holding such a viva voce. It is unfair on the part of IITD to expect from the students about ensuring that all rules/regulations are followed before scheduling a viva voce. When my viva was scheduled on 22.01.2021, I being a sincere and obedient student appeared in the viva voce on 22.01.2021.

Since the viva voce (which is a final examination) was scheduled on 22.01.2021 with Administrative Lapse, therefore to save its face and fulfil the Administrative Lapses done by IITD, the institute decided to schedule my viva voce again on 01.02.2021, which a harassment to me i.e asking me to appear again in the final exam (viva-voce) to fulfil the Administrative Lapses made on Institute's end.

Since the repeat Viva Voce on 01.02.2021 was done to fulfil the Administrative Lapse of IITD, therefore the very same examiners were put in the repeat viva and as a sincere and obedient student, I fulfilled my duty by appearing again on viva voce on 01.02.2021. Since the repeat viva was again conducted to fulfil institutional lapses and with same examiners, therefore it is unfair for IITD to penalise me for the lapses on their part. Hence the date of my defense should be considered as 22.01.2021 rather than 01.02.2021, as conducting repeat viva is neither my fault nor my responsibility. Rather, I fully cooperated with IITD in all respects, despite of life-threatening conditions of my family and myself due to COVID-19.

I have already appealed to you, in my representation dated 10.09.2021 that in the interest of fair and just resolution of my grievances, my case may be put up before senate and Board of Governors.

I therefore request IIITD to reconsider my case sympathetically and grant me a personal hearing in your office without meddling of any third person.

I shall be highly obliged.

RULES FOR PROFESSIONAL CANDIDATES REGISTRATION (PCR)

Professionals working in Industry, Research Laboratories, Government Departments/Agencies, etc. who are interested in attending one or more courses for their self-development/knowledge up-gradation would be governed by the following Rules and Regulations:

1. A professional candidate is defined as the one who is employed in an industry, a Govt. Organization, Research Laboratory, etc.
 2. Course instructors can decide whether to accept professional candidates in their respective courses. Such courses, where the instructor has agreed, will be advertised to attract good professional candidates.
 3. The fee per credit will be computed in accordance with the prevailing first-year fee of UG programs, i.e., by dividing the annual fee of the first year B.Tech. student by 32 credits, and approximating it to the nearest 1000 rupees. Currently, for years 22-23, it comes out to be Rs. 10,000 per credit.
 4. In addition, a professional candidate will be required to deposit a 'Security Deposit' of Rs.10,000/- (refundable).
 5. The Head of the Department, in consultation with the course instructor, would check the qualification and necessary background for all such applications. The eligible candidates would then be recommended to DOAA for approval.
 6. All professional candidates attending courses will have to satisfy all the course requirements similar to other regular students, e.g., appearing in all evaluations, submitting assignments, projects, etc.
 7. After completion of the course, the institute will provide a transcript to each candidate mentioning the name of the course, the number of credits, and the grade received.
 8. Based on the performance, a candidate may also be awarded a certificate of satisfactory completion of the course, if and only if the grade received in the course is at least a 'C' grade.
 9. All candidates would be issued a temporary Identity Card.
 10. They would be allowed to use the Library facility for consultation purposes only.
 11. Candidates will be provided with all the facilities required for the coursework.
 12. Such candidates will not be registered for Thesis, Independent Study, BTP and other such courses which do not have lectures.
 13. A professional candidate is not entitled to campus accommodation.
 14. The Institute will not be liable for any damages on account of any injuries/loss sustained by such candidates during their coursework at the Institute.
 15. The relevant terms and conditions may be suitably incorporated in the offer of admission.

Regulations for the Dual Degree Program in Computational Biology (CB)

1. Preamble

Dual degree programs are common in India and most IITs have it. The main motive behind such a program is to have some of the UG students of an Institute do their M.Tech. in the same Institute, so the Institute can leverage the training it had provided and the seamless transition into the M.Tech. program to benefit its research activity, as well as reduce the duration for earning the M.Tech. degree. Most dual degree programs allow for both degrees to be earned in five years. IIIT-D's dual degree program follows a similar approach as many other Institutions.

2. Admission and Requirements

2.1 The application process for the dual degree may be initiated in advance and completed well before the placement starts.

2.2 **Application Timeline:** Application for Dual Degree may be invited immediately after the declaration of the result of the 6th Semester. Scrutiny, selection of students, approval by Chair PGC and declaration of result to be completed by the middle of June.

2.3 **Eligibility:** Only students with a CGPA of 7.0 or above at the time of applying are eligible for the program. A student once selected for the Dual Degree cannot avail placement services that year. Furthermore, a student selected for the Dual degree may opt-out from migration before the add/drop date of his/her 7th semester in the B.Tech. program. The refund of the fee paid towards the dual degree will be regulated as per Note 3.6 of this Regulation.

2.4 **Transfer of 12 credits:** Any extra course credits earned during the B.Tech. program beyond what is required for the B.Tech. degree, up to a maximum of 12 credits as approved for the M.Tech CB program, may be counted towards course credit requirements for the M.Tech. degree. So, a student can do extra courses in the 3rd and 4th years (as Honors students do), and get these credits counted towards satisfying the M.Tech. course credit requirements, provided the courses are such that they can be counted for M.Tech.

2.5 **Waiver of 12 credits:** Students, who have undergone B.Tech. (CSB) program of IIIT-D, have the necessary background and strength in foundations for M.Tech.(CB) program. Hence, only up to 12 credits of the core course requirement of the M.Tech. program, which is designed to impart some core knowledge to students, is deemed to have been satisfied, and the same is waived-off for the dual degree students for earning their M.Tech degree.

(a) The following three M.Tech.(CB) core courses will be waived off only for students of the BTech (CSB) program: a) Cell Biology and Biochemistry (CBB) b) Foundations of Modern Biology (FoMB) c) Algorithms of Computational Biology (ACB).

Note: As Introduction to Mathematical Biology (IMB) is also a core course for M.Tech(CB), a dual degree student need to complete this course which is not waived; If a student has done IMB course as part of B.Tech. program requirement and not able to transfer that credit with the clause mentioned in 2.4 in this regulation, the student will have to do a BIO-numbered course in lieu of that.

(b) The core course requirements cannot be waived off for B.Tech (CSE), B.Tech (ECE), and other B.Tech (CS+X) students, including those who have done a minor in CB. Though, up to 12 credits can be waived if a student has done BIO-numbered courses in their undergraduate program (only counting at most one 3xx level and two or more 5xx level courses). If a student has done M.Tech (CB) core courses as a part of their electives, then in lieu of these courses, he or she will have to do other courses from the M.Tech (CB) curriculum.

Note: The courses considered for transferred of credits with the clause 2.4, can't be considered for waiver.

2.6 Mandatory requirement to complete OOPD course can be waived for Dual Degree students if they have taken AP during B.Tech.

2.7 Mandatory requirement to complete RM course can be waived for Dual Degree students if they have taken RMSSD during B.Tech.

2.8 A dual degree student will be considered as a B.Tech. student till the time he/she completes the requirements for the same; thereafter he/she will be considered as an M.Tech. student. The date for each degree will be based on the date of completing the requirements for that degree.

2.9 The dual degree student must spend at least two semesters as an M.Tech. student.

2.10 A dual degree student must do an M.Tech. thesis, which may be a continuation of the work done in BTP. The goals of the MTech thesis should be aligned with the objectives of the MTech (CB) program.

3. Notes:

3.1 The fee for the M.Tech. portion of the dual degree program will be half of regular M.Tech. fee.

3.2 The dual degree student will not be eligible for campus placement in his/her B.Tech. portion, and will be eligible only in his/her last year to use placement services.

- 3.3 If a student does 12 credits extra in 3rd/4th years, as allowed, he/she will have to do 8 credits more in the 5th year, and at least 16 credits of M.Tech. thesis, for the M.Tech. degree. The minimum number of credits for M.Tech. part under the Dual Degree program is 36.
- 3.4 After the declaration of 8th-semester results, the student should specify which courses should count for B.Tech. and which for the M.Tech. degree.
- 3.5 Students should be encouraged to take GATE in their 4th year to benefit from the scheme.
- 3.6 It is clarified that after admission to the Dual Degree program the student is ineligible for placement. No refund of the fee will be made if he/she does not join except if he/she goes for higher studies in which case some amount is deducted (the amount to be deducted will be decided by the Competent Authority).
- 3.7 On completion of B.Tech. requirements, the B.Tech. degree may be given on submission of No Dues Certificate.
- 3.8 If he/she cannot complete the M.Tech. part of the Dual Degree program, no fee refund can be made.
- 3.9 Internship rules for dual degree students will be the same as for M.Tech. students of the respective batches.

 2. All nominations will be reviewed by the Alumni Awards Committee, which will consist of:
 - Associate Dean/Dean of Communication & Alumni Affairs
 - Alumni Committee Chair
 - Associate Dean/Dean of Student Affairs
 - General Manager (Placements)
 - One Representative from the Academic Affairs
 - Representative of Office of Alumni Affairs

- One Alumni Representative from B.Tech, M.Tech., Ph.D. programmes each
3. The Alumni Awards Committee will select the Alumni Award winners under each award category.
 4. The Alumni Award winners will be notified by the Dean of Communication and Alumni Affairs.
 5. Alumni nominated but not chosen by the Alumni Awards Committee will remain in a nomination pool for consideration in subsequent years.
 6. The Alumni Awards will be presented every year at the Foundation Day ceremony of the institute held in September. In case the Alumni Awards committee is not satisfied with the nominations received for a particular category or categories, they can choose to eliminate the award category/categories in that specific year.
