54.2 CONFIRMATION OF MINUTES OF THE 53rd MEETING OF THE SENATE

The Minutes of the 53rd meeting of the Senate held on February 09, 2022, placed at <u>Annexure-I</u>, were circulated among the members. No comments have been received. The Senate may consider the same for confirmation.

54.4 ITEMS FOR INFORMATION/ RATIFICATION

54.4.1 General Matters

54.4.1.1 To report the status of Cycle 2 NAAC accreditation

The Self Study Report (SSR) for NAAC accreditation (Cycle 2) was submitted successfully on April 7, 2021. The Peer Team Visit (PTV) of NAAC was conducted from 15-17 March, 2022. A Review Committee was set up to examine the outcome and it was decided to apply for reassessment.

The above is reported for the information of the Senate.

54.4.1.2 To ratify the Academic calendar for the Summer Term 2022

The Chairman, Senate has approved the Academic calendar for the Summer Term 2022 placed at Annexure-III

The Senate may kindly ratify the approval given by the Chairman, Senate.

54.4.1.3 To report the status of Suit No. CJ/1151/2018, filed by Animesh Attri in the court of Hon'ble Shri Gauray Gupta, Civil Judge Junior Division-x, Civil Courts, Amritsar

In the last hearing held on April 20, 2022, the Hon'ble court has disposed-off the suit of the Petitioner in favour of the Respondents. The detailed order of the Hon'ble Court is awaited.

54.4.1.4 To report the status of Suit No. CS SCJ/116/19, filed by Nikhil Gautam in the court of Hon'ble Shri Sushil Anuj Tyagi, JSCC-cum-Addl. SCJ-cum- Guardian Judge, South East, Saket, District Court, New Delhi

The next date of hearing is scheduled for May 25, 2022.

54.4.1.5 To report the status of the Compliance Affidavit filed by the Institute in the matter of Courts on its Motion in re: Suicide Committed by Sushant Rohilla, Law Student of I.P. University (W.P.(CRL) 793/2017)

The next date of hearing is scheduled for May 23, 2022

54.4.1.6 To report the status of Complaint No. 72/2020, filed by Dr. Deep Raj Gupta, before the Hon'ble District Consumer Disputes Redressal Forum, South Delhi-II, for a refund of fee of Rs.75,000 paid towards the admission of his son, Aitik Gupta, B.Tech. ECE.

The first hearing was held on April 5, 2022. The next date of hearing is scheduled for July 5, 2022.

54.4.1.7 To ratify the approval given by Chairman Senate to Aakansha Sneh for allowing one extra chance to clear the annual review exam

A PhD student, Ms. Akanksha Sneh (advised by Dr. Shobha) appeared for her second attempt (she was already under academic warning) to clear the annual (qualifying) exam and she received an F. Subsequently, following the Regulations, she was issued a termination letter. However, she has requested to allow another chance. The request is supported by the Advisor and the HoD. Also, as agreed in recent ECE FM, from this time onward, the Department of ECE will also follow the Institute rules of Academic Review.

Her records were looked into and it was believed that a second chance should be provided to her given her other academic records. Therefore, the DOAA recommended allowing her an additional chance to clear her annual review. The Chairman Senate has kindly approved the recommendation.

The Senate is requested to kindly ratify the approval given by Chairman Senate.

54.5 ITEMS FOR DISCUSSION AND CONSIDERATION

54.5.1 UG Matters

54.5.1.1 To consider the recommendations of the Academic Affairs Committee (AAC) regarding revision of Academic Warning rules mentioned in point 7.2 and 7.3 of B.Tech. Regulations

The AAC at its 18th meeting held on April 13, 2022 deliberated on the matter and recommended that

- I. Students with a fail (F) grade in a course, in a semester, should not get the Academic Warning. Only " if he/she gets a SGPA of 4.5 or less in a semester, or has a CGPA of 4.5 or less at the end of the semester", he/she will be placed under Academic Warning on the grounds of inadequate academic performance for one (subsequent) semester. This Academic Warning will not lead to the termination of a student.
- II. For 7.3 Rules for promotion to next semester for 2nd, 3rd and 4th-year students there will be no change in the Regulations

The Senate is requested to consider and approve the above recommendation of the AAC.

54.5.1.2 To consider a proposal for creating three supernumerary seats in the B.Tech.(Computer Science and Social Sciences) program for providing admission to the students excelling in the Business Blaster (BB) scheme of the Government of Delhi for the AY 2022-23.

IIIT-Delhi is committedly aligned to the Business Blaster (BB) Scheme of the Government of Delhi and proposes to create **three supernumerary seats** in the B.Tech.(Computer Science and Social Sciences) program for providing admission to the students excelling in the Business Blaster (BB) Project under Entrepreneurship Mindset Curriculum (EMC) in AY 2022-23. The admission of these students against the three supernumerary seats is proposed to be regulated as follows:

Channel of Admission – Through the IIIT-Delhi Admission process (along with the process of admission to B.Tech.(CSSS) program on the basis of class XII marks (of 2022).

Eligibility Criteria – The candidates seeking admission against these three supernumerary seats need to comply with the following:

- 1. Must be a position holder of the Business Blaster (BB) Project of the Government of Delhi, and
- 2. Must possess 70% marks in aggregate for five subjects and 70% in Maths in class XII from CBSE Board or equivalent. Candidates belonging to Business Blaster Project having Physics, Chemistry, and Maths in class XII are also eligible to apply through IIITD Admission process as well as through JAC. The candidate should have done schooling from a school located in the National Capital Territory (NCT) of Delhi.

Relaxation in Eligibility Criteria- Candidates belonging to the following categories shall be allowed a relaxation in the eligibility requirement. The relaxation is applicable both in Maths and overall percentage as detailed below:

Scheduled Castes (SC) and Scheduled Tribes (ST): A relaxation of 10 percent marks in the eligibility requirements.

Defence (CW): A relaxation of 5 percent marks in the eligibility requirements.

Persons with Disability (PwD): A relaxation of 5 percent marks in the eligibility requirements. **OBC:** A relaxation of 5 percent marks in the eligibility requirements.

NOTE: There is no marks relaxation for EWS category candidates.

Applicable fee- As applicable to other admitted candidates of the Admission year 2022-23. The candidates admitted through this channel will be eligible to avail Merit-cum-Means fee waiver scheme of the Government of NCT of Delhi as well as fee waiver scheme of IIIT-Delhi.

Admission Criteria- As per the merit list of Business Blaster scheme of the Government of Delhi for the AY 2022-23.

The Senate is requested to consider and approve the above proposal.

54.5.2 PG Matters

54.5.2.1 To consider the recommendation of the Academic Affairs Committee (AAC) to review the guidelines for the Doctoral Dissertation Award.

The AAC Chair apprised the members of the background. It was noted that while recommending various awards and medals for the 10th convocation, the Senate, in its 52nd meeting held on October 4, 2021, had advised the AAC to have a relook at the guidelines for the Doctoral Dissertation Award. Accordingly, the AAC in the 17th meeting held on January 26, 2022 and 18th meeting held on April 13, 2022 reviewed the guidelines for the Doctoral Dissertation Award. After detailed deliberations, the AAC recommended the following criteria for selecting the students for the award in the forthcoming convocation:

- a. All the external examiners should have rated the thesis in category 'A' in the initial review.
- b. The form seeking recommendations from external examiners should clearly mention our expectations from the thesis.
- c. The Academic Section will approach the concerned external examiners after the thesis defense (Viva-voce) with a request whether he/she would recommend the thesis for the Doctoral Dissertation Award. The examiner with a positive recommendation will also be requested to briefly highlight the strengths of the thesis and a justification for recommending the thesis.
- d. If more than 10% of the students become eligible for the award, then the criteria may be reviewed after the next convocation.

The AAC also approved a form (<u>Annexure-IV</u>) and the covering letter (<u>Annexure -V</u>) for seeking information from the external examiners. The AAC Chair also proposed to collect more details from the external examiners about the quality of research being carried out at the Institute, and shared a questionnaire prepared for this purpose. The AAC thoroughly discussed the questionnaire and suggested a few changes to it. The PhD thesis evaluation form is prepared and also approved by AAC through circulation which is placed in <u>Annexure VI</u>.

The Senate is requested to consider and approve the above recommendation of the AAC.

54.5.2.2 To consider the recommendation of the Academic Affairs Committee (AAC) regarding the formulation of the policy of M.Tech. and Ph.D. theses submission in the Library and making theses public

The AAC at its 18th meeting held on April 13, 2022 discussed the matter regarding the formulation of the policy of M.Tech. and Ph.D. theses submission in the Library and making theses public, and observed/recommended as under:

"Dr. Debajyoti Bera presented this item and informed that generally Ph.D. & M.Tech. Theses which students submit in the Library should be considered public, but sometimes student/advisor submit a request that their thesis should not be made public due to various reasons like patent, sensitive research, etc. Right now, students just send an email to Mr. Rajendra Singh in the Library that their thesis work should not be made public, but it is felt that there should be some policy or guidelines to implement the embargo policy.

The AAC members discussed and suggested that after the viva-voce examination, the Ph.D./M.Tech. Thesis, by default, should be made public, but in case a student wants to put an embargo, then the concerned students should submit an application to DoAA through a form signed by the Advisor with justification. If the request is accepted, the embargo will be put for 2 years. After 2 years, the thesis will automatically be made public. Till then only Title and Abstract will be published.

However, if a student still wants to put an embargo for another 2 years, then he/she should submit a request for an extension. On receiving such a request, the DoAA will form a committee to look into the justification to see if an embargo for another 2 years should be

approved or not. The format for seeking approval from DoAA will be prepared by Mr. Rajendra Singh, Manager (library and Information Services)."

The Senate is requested to consider and approve the above recommendation of the AAC.

54.5.2.3 To consider the recommendations of the Academic Affairs Committee (AAC) regarding guidelines for sponsored Ph.D. students - for payment of Tuition fees, dates for fees payment, date for fee refunds, etc.

The AAC at its 18th meeting held on April 13, 2022 discussed the matter related to sponsored Ph.D. students - for payment of Tuition fees, dates for fees payment, date for fee refunds, etc. and recommended as under:

"The AAC discussed the matter and suggested that the fee will be refunded on a proportionate basis semester-wise, if a student withdraws before 1st semester add/drop, his/her whole semester fee along with the security deposit will be refunded. If the withdrawal is after add/drop of 1st semester only half of the fees, i.e. fee part for Semester 2, will be refunded along with the security deposit. So, effectively the fee will be divided into two parts and will be counted semester-wise. If a student withdraws after the add/drop date of that semester, then the whole fee for that semester will be forfeited."

The Senate is requested to consider and approve the above recommendation of the AAC.

54.5.3 Other Matters

54.5.3.1 To consider the recommendation of the Academic Affairs Committee (AAC) for allowing IIIT-Delhi students to attend classes at some other Institutes/Universities where there is no MoU

The AAC at its 18th meeting held April 13, 2022 discussed the suggestion of Dr. Kiriti Kanjilal made in the 15th AAC to allow IIIT-Delhi students to attend classes at some other Institutes/Universities where there is no MoU and observed/recommended as under:

"Dr. Kiriti Kanjilal apprised the members of the background. After detailed deliberations, it was suggested that we should clarify in the regulations that the CGPA of the course taken at other universities with whom we have no MoU will not contribute towards the CGPA at IIITD. For the exchange program, we will refer to the MOU to know if the grades should be counted in CGPA or not. If any student does any course at some other University where there is no MOU, then by default, the grades will not be counted towards the CGPA. These will only contribute to the total credits for graduation at IIITD.

The Senate is requested to consider and approve the above recommendation of the AAC.

54.5.3.2 To consider the recommendations of the Academic Affairs Committee (AAC) regarding the formulation of the process for the approval of a new course

The AAC at its 18th meeting held on April 13, 2022 discussed the matter regarding the formulation of the process for the approval of a new course and observed/recommended as under:

At present, the following is the process for approval of a new course:

- a. First the course structure is prepared by faculty and submitted to the respective department.
- b. The same is shared with the departmental faculty members for suggestions.
- c. After incorporating the suggestions from department faculty, the course is then shared with all faculty members of IIITD.
- d. Suggestions received are suitably incorporated by the concerned faculty member and then it is put up to AAC for approval.

The AAC therefore, suggested taking this item to the Senate for approving the same process, which is being followed for approval of a new course.

54.5.3.3 To consider the recommendations of the Academic Affairs Committee (AAC) regarding creating a scholarship for final year students based on the all-around contribution of the candidate in the first three years at IIIT Delhi

The AAC its 18th meeting held on April 13, 2022 had noted and expressed concern on the sad and untimely demise of one of our students, Kartikeya Gupta, Roll No 2019427, due to cancer last year. It was also noted that his parents want to institute a scholarship (1 lakh per year) in his memory.

During the course of discussions, the Chair UGC presented this item and informed that Kartikeya Gupta was academically good and he loved the culture and freedom at IIITD. So his parents want to give back to IIITD in the name of Kartikeya Gupta to academically good students.

The Chair UGC also informed that based on the discussions with his parents, a draft proposal named "Kartikeya Gupta Memorial Scholarship" has been prepared and the award will be given during the Foundation Day of IIITD.

The AAC discussed the proposed document "Kartikeya Gupta Memorial Scholarship", and suggested that this proposal should first be discussed with parents and find out if the parents agree to the proposal. We should also check with the parents as to how many years they want to support this scholarship. The Chair UGC was requested to discuss the matter with the parents in light of the suggestions made at the meeting and come back to AAC again for further deliberations.

Further to above, it is submitted that the matter has been discussed with the parents, and they have appreciated the proposed document for scholarship and accepted it without any change. They have also offered Rs.25 Lakhs as a corpus for the scholarship the interest of which will be used each year for this scholarship. The proposed guideline for the above scholarship is placed at Annexure VII

The Senate is requested to consider and approve the above institution of above scholarship.

MINUTES OF THE MEETING

53.1 WELCOME AND OPENING REMARKS BY THE CHAIRPERSON

On behalf of the Senate of the Institute, the Chairman conveyed sincere thanks to all the outgoing Senate members for their valuable contributions made during their tenure, which were extremely useful for evolving the right policies and maintaining the high standards of education at the Institute and hoped to get their continued support and cooperation in times to come. The Chairman also welcomed the new Senate members and hoped to receive their valuable suggestions in evolving the right policies and elevating the standards of education at the Institute.

The Chairman, Senate also informed that in terms of Statute 35 (clause 2(5), he has approved fresh/renominations to the Academic Senate, on behalf of the Senate for the year 2021-22. Accordingly, a total of 40 new members (29 IIITD faculty + 9 external members + 2 alumni) are nominated to the Academic Senate and their names are shown in the list under new members of **Appendix I**. As per the approved composition, Registrar is the non-voting Secretary of the Senate. Student Representative(s) attend the meetings as a special invitee(s). He requested the Senate to ratify the nominations.

The Senate ratified the above nominations to the Academic Senate. Thereafter, the agenda items were taken up for discussions.

53.2 CONFIRMATION OF MINUTES OF THE 52ND MEETING OF THE SENATE

The Dean of Academic Affairs informed that no comments were received on the Minutes of the 52^{nd} meeting of the Senate held on October 04, 2021. The Senate, therefore, confirmed the Minutes of the 52^{nd} meeting as circulated.

53.4 ITEMS FOR INFORMATION/ RATIFICATION

53.4.1 General Matters

53.4.1.1 To report the progress of the NAAC Self Study Report (SSR) submitted for Cycle 2 accreditation

The Dean of Academic Affairs informed that SSR for Cycle 2 of NAAC accreditation was submitted successfully on April 7, 2021. Subsequently, as per the advice of NAAC, the payment of Rs.5.78 lakh towards the visit has been made and the NAAC has now informed that their team will visit the Institute from 15-17 March, 2022. The Senate noted the position.

Action: Academic Section

53.4.1.2 To ratify the approval given by Chairman, Senate for inclusion of the name of Mr. Aman Gulia, (2017328) in the graduating list of 10th Convocation

The Dean of Academic Affairs informed that after the last convocation (i.e. 10^{th} Convocation held on October 16, 2021) a case of Mr. Aman Gulia, (2017328), student of B.Tech. (CSSS) program came to notice where the student had pointed out that he fulfilled the degree requirement but his name was not on the list of graduating students. The matter was thoroughly examined and it was found that he indeed fulfilled the degree requirement. However, due to oversight of both student and admin (Ms. Prachi Mukherjee) his name was missed.

Subsequently, on the recommendation of the Dean of Academic Affairs, the Chairman, Senate has approved for inclusion of the name of Mr. Aman Gulia, (2017328) in the graduating list of 10th Convocation with degree date 21st September, 2021, with the advice to ensure that adequate checks are put in place so that such cases do not arise in the future. The Senate noted that the existing process is being reviewed thoroughly to provide additional checks to avoid such instances in future. After a brief discussion, the Senate ratified the approval given by the Chairman, Senate.

Action: Academic Section

53.4.1.3 To ratify the approval given by Chairman, Senate for change of course for B.Tech. (CSB) from "Algorithm Design (B)" to "Analysis and Design of Algorithms (ADA)"

The Dean of Academic Affairs informed that on the proposal of CSE and CB departments, recommended by AAC, the Chairman, Senate has approved the change of course for B.Tech.(CSB) program from "Algorithm Design (B)" to "Analysis and Design of Algorithms" which is offered to B.Tech. (CSE) students. After a brief discussion, the

Senate ratified the approval given by the Chairman, Senate for incorporating the change in the relevant regulations.

Action: Academic Section

53.4.1.4 To ratify the approval given by Chairman, Senate for change of current guidelines as 'USD and equivalent' for payment of honorarium to external examiners

The Dean of Academic Affairs informed that currently the payment of honorarium is being made in USD to Ph.D. external examiners from abroad. This causes an unnecessary delay for examiners who do not live in the USA. Therefore, the Chairman, Senate, on the recommendation of the DoAA, has approved to change the current guidelines as 'USD and equivalent' for payment of honorarium to external examiners. It was noted that there is no change in the amount approved etc. and it is only to enable payments to examiners (outside the US) in their local currency. After a brief discussion, the Senate ratified the approval given by the Chairman, Senate.

After a brief discussion the Senate ratified the approval given by the Chairman, Senate and recommended for further approval of the Board of Governors.

Action: Academic Section

53.4.1.9 To ratify the approval given by Chairman, Senate to the recommendation of the AAC for adding PIS (Prototyping Interactive Systems - DES206) and DIS (Design of Interactive Systems - DES205) courses as additional courses in [Human Computer Interaction/TOC]# for the 2019 batch

The Dean of Academic Affairs informed that the AAC at its 17th meeting held on January 26, 2022 had considered and agreed to a request received from the CSE department to consider PIS (Prototyping Interactive Systems - DES206) and DIS (Design of Interactive Systems - DES205) courses as additional courses in [Human Computer Interaction/TOC]# for the 2019 batch.

It was noted that from the 2020 batch, it is [Practical Bioinformatics/Prototyping Interactive Systems/Theory of Computation]#

Subsequently, considering the urgency the Chairman, Senate, on the recommendation of the Chair AAC and the DoAA, has approved, on behalf of the Senate, for implementation of the above recommendation of the AAC. After a brief discussion, the Senate ratified the approval given by the Chairman, Senate.

Action: Academic Section

53.4.1.10 To report the status of B.Tech. admissions for the Academic year 2021-22

The Dean of Academic Affairs presented the details of admissions made to B.Tech. programs through various modes for Academic year 2021-22. He also apprised the members through slides of the various cut-offs at which the admissions were closed with Bonus and without Bonus points. He also answered the queries made by the members during the course of deliberations about the minimum and maximum cut-offs of IIITD visà-vis DTU and NSUT in various disciplines. During the course of discussion following points were noted;

- 1. The DOAA presented the summary of admissions through various modes where it was noted that the vacancy within the approved intake is mostly in the supernumerary seats for foreign students.
- 2. The DOAA apprised the members regarding the admission through Bonus points, where it was noted that out of 45 candidates admitted, 37 candidates would have in any case got admission based on their merit without Bonus. Only 8 candidates got the benefit of Bonus which are mostly from NTSE, KVPY, Olympiads categories. Only one candidate is from Sports. The DOAA also apprised the members that the process of Bonus verification is cumbersome and time consuming. For the current year, 1079 appications were verified during the admission process where a large number of applications needed to be verified within a specified time. For certain categories like sports where a large noumber of applications are received, there are limited resources available to check the authenticity of the certificates.

The Senate noted the issue and observed that the purpose of giving Bonus points is to augment inclusivity, and to increase the student diversity at IIIT-Delhi. The Senate desired that the present criteria for the Bonus points be reviewed. A committee may look into all the issues involved in this process including the performance of the admitted students with Bonus points and make appropriate recommendations to the Senate.

3. The DOAA also apprised the members and shared the number of admitted candidates ranks in various rank-brackets for last four years, which is as under:

Considering the above data, the Senate noted that the closing rank has dipped in recent years. Some of the external members suggested that the comparision should only be done for general category to analyze whether the gap is increasing or decreasing. It was also suggested to check the participation data of Delhi candidates in JEE mains which will also indirectly affect this rank distribution as we have 85% reservation for Delhi candidates.

Thereafter, the Senate noted with satisfaction the admissions made for the Academic year 2021-22 and accepted the newly-admitted students as per the list annexed to the agenda.

53.4.1.11 To report the status of M.Tech.(CB) admissions through DBT admission process for the Academic year 2021-22.

The Dean of Academic Affairs informed that the M.Tech. Admission report for 2021 had already been reported in 52nd Meeting of the Senate held on October 04, 2021 where it was informed that the result of M.Tech. (CB) admission through DBT is awaited. The same has now been completed and the following 6 students (out of 15 seats) have been admitted to the M.Tech. (CB) program w.e.f. December 13, 2021.

After a brief discussion, the Senate noted the above position and recommended it to the BoG. The Senate also desired to re-look into the M.Tech.(CB) program offering and its

admission process for further improvement from the perspective of the number of admissions.

53.5 ITEMS FOR DISCUSSION AND CONSIDERATION

53.5.1 *UG Matters*

53.5.1.1 To consider the recommendation of the Academic Affairs Committee (AAC) for allowing the extension of another semester to Mr. Akash Nagrath (2015125), a UG student to enable him to complete the degree requirements.

The Dean of Academic Affairs informed that the HoD (ECE) had considered and recommended the case of Mr. Akash Nagrath (2015125), a UG student for allowing him an extension of another semester to enable him to complete the degree requirements. Subsequently, the AAC at its 15th meeting held on September 30, 2021 has considered his case and agreed to the above recommendation of the HoD (ECE) and recommended that he may be allowed another semester to complete the degree requirement with the warning that no further extension will be given to him. The AAC also suggested sending letters to the concerned students on completion of the 4th year so that they complete within a maximum of 6 years.

After detailed deliberations, the Senate approved the above recommendations of the AAC.

Action: Academic Section

53.5.1.2 To consider the recommendation of the Academic Affairs Committee (AAC) for allowing UG student to register for IP/IS without CGPA requirement.

The Dean of Academic Affairs apprised the members of the background and informed that currently there is a CGPA requirement for doing IP/IS in the B.Tech program, but there is no CGPA requirement for doing BTP. He also informed that the AAC at its 17th meeting held on January 26, 2022 deliberated on the matter and felt that IP / IS may give a hands-on experience to students. It may also boost the confidence of the students who are not able to perform well in the regular courses. In view of this, the AAC has recommended that there should not be a CGPA requirement for doing IP/IS, and that the CGPA bar should be removed from the Academic year 2022-2023. During the course of deliberations the queries made by the members were answered by the DoAA. After detailed deliberations, the Senate approved the above recommendation of the AAC with the advice to make necessary changes in the UG Regulations.

Action: Academic Section

53.5.2 PG Matters

53.5.2.1 To consider the representation of Ms. Rupal Jain for the change of semester in the Provisional Certificate

The Dean of Academic Affairs apprised the members of the case of Ms. Rupal Jain who had joined B.Tech.(CSE) program in July 2015 and opted for a dual degree (B.Tech. and M.Tech. in CSE). Her B.Tech. program was completed in 2019 and effectively the M.Tech. part of dual degree program started from July, 2019. She has completed the requirement of M.Tech. (CSE) degree in Winter 2021 semester. Accordingly, she was issued a Provisional Certificate showing the completion of degree requirement with degree date of 21st June, 2021. Against this decision of the Institute, she made a representation dated September 10, 2021 wherein she raised several points and pointed out that there has been unfair change of semester in her graduation Provisional Certificate issued to her because she completed the degree requirement in Monsoon 2020 semester. He informed that the points raised by her were examined and a detailed reply was given to her vide letter No.IIITD/Acad/2021/942 dated 20.09.2021. He further informed that not being satisfied with the reply given by the Institute, she has made another representation dated October 4, 2021 wherein she has made similar points and requested not to shift the graduation date by 6 months as that will have a very bad impact on her career.

During the course of discussions, it was noted that she was allowed to change the M. Tech. Thesis Supervisor and also permitted to do the 16 credits of the Thesis work within one semester, i.e. Monsoon 2020 with an overload of 4 credits. This was allowed to her as a special case despite the restriction of not allowing for students having CGPA below 8.00; her CGPA was less than 8.00. It was also noted that she completed 20 credits of the course work requirements by the Monsoon 2020 semester. However, her thesis defense, an integral part of M.Tech., was pending. For the thesis, she was also required to successfully defend it to complete the graduation requirement as per the guidelines stated in the PG Regulations point 15.4.

It was also noted that the procedures for Thesis evaluation provide that students are expected to complete their M.Tech. thesis defense one month prior to the specified degree date. The procedures also, interalia, mention that "Supervisor will inform the defense details to admin, and admin will send invitation and will oversee other arrangement". Accordingly, the Supervisor of the student had filled the thesis defense request form on November 17, 2020 to hold the defense on December 14, 2020. However, on December 06, 2020, her Supervisor requested the DOAA to keep in abeyance the earlier proposed defense due to the family issue of the student due to COVID and requested the DOAA to extend the thesis defense deadline and final thesis report submission date beyond December 21, 2020 which was the deadline for getting graduation date 21st January 2021. Looking at the situation of student due to COVID, the DOAA had then given permission till December 31, 2020 as the deadline, however she did not defend the thesis by that time and the Advisor (Supervisor) requested again to extend the deadline of thesis defense and report submission upto January 15, 2021, which was also approved by the Chair PG Affairs and the DOAA. But she could not complete the thesis defense by the given date. Later on, the Academic Section received an email from the Advisor about the grade awarded to her after the thesis defense on January 22, 2021. The Academic Section had no prior information about the date of holding the thesis defense on January 22, 2021, and no official notification was issued for the defense where all faculty and students are invited for the thesis defense. After it was pointed out that the thesis defense was conducted on January 22, 2021 was not as per procedure, the Advisor vide email dated January 26, 2021 requested the Academic Section to hold the defense on February 1, 2021 with the same examiners as proposed earlier. Thereafter, the Academic Section after taking due approval for the examiners as per point/clause 15,4 (b) of the PG Regulation and M.Tech. THESIS-SP-CapP Evaluation Process (https://iiitd.ac.in/academics/resources) organised the defense with due notification. Thereafter, as per records she submitted the final report on February 15, 2021 which was approved by the Advisor on the same day. As she submitted the report on February 15, 2021, her graduation date is considered 21st June 2021 as per guidelines approved by the Senate. Even though she completed the course work requirement in the previous semester, i.e Monsoon 2020, she completed the degree requirement by successfully completing the thesis defense and by submitting the final report in Winter 2021.

During the course of discussions it was also noted that she has not followed the procedures of thesis defense prescribed by the Institute. Hence her allegation that the thesis defense was organized by the Institute on February 01, 2021 was to cover the lapses on the part of the Institute is incorrect and baseless. It was noted that no valid reason has been given by her to change the Semester (i.e. from Winter 2021 to Monsoon 2020) and to consider the date of thesis defense as January 22, 2021 rather than February 01, 2021. Moreover, the three degree dates approved by the Senate are sacrosanct and cannot be changed as each graduation date is linked to a semester in which the requirement is completed by the student. After protracted deliberations the Senate did not find any justification to accept her request for the change of semester/date of thesis defense and thus the Senate concluded that the degree date in this case will remain unchanged i.e. Winter 2021 (21st June 2021) as per Regulations.

Action: Academic Section

53.5.2.2 To consider the recommendation of the Academic Affairs Committee (AAC) for making a minor change in the Internship guidelines of M.Tech. under "Collaborative Thesis with Industry or Academia/Guidelines for Collaborative Thesis

The Dean of Academic Affairs informed that the AAC at its 15th meeting held on September 30, 2021 discussed a proposal from Associate Dean IRD for making a minor change in the Internship guidelines of M.Tech. under "Collaborative Thesis with Industry or Academia/Guidelines for Collaborative Thesis and observed/recommended as under:

"The Associate Dean IRD presented the proposal on collaborative research projects with Industry. The AAC discussed the proposal in detail and noted that this proposal can be implemented by making the following minor change in the Internship guidelines of M.Tech. under "Collaborative Thesis with Industry or Academia/Guidelines for Collaborative Thesis":

(b) Such students should take necessary approvals from the advisor and the academic office before starting their work. The student has to submit the approval of the supervisor to the academic office at least one week before the list of eligible students for internship +FT offer is submitted to the Placement Office so that they can be excluded from this list."

After a brief discussion, the Senate approved the above recommendation of the AAC.

Action: Academic Section

53.5.2.3 To consider the recommendation of the Academic Affairs Committee (AAC) for starting M.Tech. (CB) Dual Degree program.

The Dean of Academic Affairs informed that the AAC at its 17th meeting held on January 26, 2022 has recommended the proposal for starting a Dual Degree program in M.Tech. (Computational Biology). Thereafter, Dr. Ganesh Bagler briefly explained the salient features of the proposal and answered the queries made by the members. After detailed deliberations, the Senate approved the proposal for starting M.Tech. (CB) Dual Degree program, recommended by the AAC, placed at <u>Appendix-II</u>. The same will be implemented from next Academic Year 2022-23.

Action: Academic Section

53.5.2.4 To consider the recommendation of the Academic Affairs Committee (AAC) regarding Course credit requirements for Mr. Vishal Kumar as per current Ph.D. regulations.

The Dean of Academic Affairs informed that the AAC at its 17th meeting held on January 26, 2022 has noted that Mr. Vishal Kumar has done B.Tech. and M.Sc. in Computer Science (from Cochin University of Science & Technology) and felt that the Ph.D. coursework requirement for such students should be the same as that for Ph.D. students admitted with an M.Tech. degree. The AAC has therefore, recommended 16 credits of Ph.D. coursework for students admitted with 4 years of B.Tech. and 2 years of M.Sc. During the course of deliberations, the DoAA clarified the queries made by the members. After detailed deliberation the Senate approved the recommendation of the AAC and advised to make necessary changes in the Regulation.

Action: Academic Section

53.5.3.1 To consider the draft of the PG Diploma Certificate

The Dean of Academic Affairs informed that the Institute is currently offering two diplomas, one in collaboration with IBM and the other in collaboration with Great Learning. He also informed that a copy of the initial draft of the Diploma Certificate, placed at Appendix- III, was shared with the Committee which had looked into the design of Degrees/certificates awarded in the 10th Convocation and the Committee has considered and recommended the above draft format for approval. It has also been decided not to mention the company's name on the Diploma Certificate. The same practice is being followed by other academic institutes (such as IIIT-B) offering diplomas in collaboration with industries. After a brief discussion the Senate approved the format of the PG Diploma Certificate recommended by the Committee.

Arising out of discussion one of the external member suggested having Hindi version of this Certificate as well as other degree certificates. There was no consensus on having dual version of certificates, where Chairman Senate suggested that this matter may be taken up separately.

Action: Academic Section

To consider the list of students who have completed graduation requirements on 21st January 2022.

The Dean of Academic Affairs presented a list of 32 students who have completed graduation requirements on January 21, 2022. After a brief discussion, the Senate approved the list of 32 students who completed graduation requirements on January 21, 2022 placed at <u>Appendix-IV</u>.

Action: Academic Section

53.5.3.3 To consider the End of Semester Summary Report (Monsoon 2021)

The Dean Academic Affairs presented the summary of various activities of academics undertaken in the previous semester (Monsoon 2020) including the performance of UG/PG/Ph.D. After detailed deliberations, the Senate noted the position.

Action: Academic Section

53.5.3.4 To consider the recommendation of the Academic Affairs Committee (AAC) to allow PGDDS&AI students to clear their Backlog to get the Diploma

The Dean of Academic Affairs informed that the following PGDDA&AI students were not able to complete a few of their courses due to the ongoing pandemics. On the request of students, a committee consisting of Prof. Vikram Goyal (Project Director), Dr. Debarka Sengupta, and Anuka Kumar (IBM) looked into their cases and recommended that they may be given another chance to complete their program looking at the current pandemic situation.

The AAC discussed the matter and recommended to allow these students with a fee of Rs.2500/- per credit, i.e. for two credits course the fee is Rs.5,000/- After detailed deliberation the Senate approved the recommendation of the AAC.

Action: Academic Section

53.5.3.5 To consider the recommendation of the Academic Affairs Committee (AAC) to establish Alumni Awards at the Institute.

The Dean of Academic Affairs apprised the members of the following recommendations of the 16th AAC held on January 19, 2022.

"The proposal was presented to AAC by Dr. Paro Mishra (Associate Dean, Communication and Alumni Affairs) for establishing Alumni Awards to recognize the outstanding accomplishments and achievements of IIIT-Delhi alumni who are making a difference in the world through their professional and/or academic achievements, or through their significant contributions to the community. She explained the salient features of the proposal. Dr. Ganesh Bagler (former ADoCA) was present at the meeting and also clarified the points raised by the members. After detailed deliberations, the AAC agreed to the proposal placed as Annexure-X and recommended the same to the Senate for approval. The Institute will honor the recipients of the awards on the 'Foundation Day' of IIIT-Delhi.

During the course of meeting, some of the AAC members also discussed and suggested that apart from certificates, a medal/memento/plaque bearing the title of the award, name of the awardee, year, etc. should also be given to honor the recipients of the awards. The suggestion was approved by the AAC."

During the course of discussions, Dr. Paro Mishra (Associate Dean, Communication and Alumni Affairs) briefly explained the salient features of the proposal and answered the queries made by the members. One of the external members suggested that since IIITD is still in the developing stage we should start with Young Alumni Award only and review the proposal after 5 years. After detailed deliberations the Senate agreed to the proposal for 'Young Alumni Award' and recommended for approval of the Board of Governors. The number of Young Alumni awards, nomination criteria and nomination procedure will be as per details placed at Appendix-V.

Action: Academic Section

53.5.3.6 To consider List of Experts for Faculty Selection Committees.

The Chairman presented the background of the proposal and the list of Experts in different areas belonging to various institutions/universities/organizations for Faculty Selection Committees. He informed that, as a process, the existing list of Experts is augmented by periodically inducting new people and the list is placed before the Senate for consideration. After detailed discussions, the Senate approved the names of Experts listed in Appendix-VI, for inclusion in the panel for the Selection committees.

The Senate further authorized the Director (Chairman, Senate) to add more names of Experts in future, as and when required.

Action: DOFA

53.5.3.7 To consider the guidelines for non-degree/professional candidates from industry to attend regular courses offered at IIIT-Delhi.

The Dean of Academic Affairs apprised the members of the following recommendatons of the AAC:

"In the 15th AAC meeting held on September 30, 2021, the AAC Chair apprised the members of a recent request received from the Department of ECE about offering a course for industry personnels. It was noted that currently, we have a provision for this, where a candidate pays Rs. 8000/- per credit along with Rs.5000/- as security. However, a formal approach may be adopted to regularize the process. During the discussion, it was suggested that this fee amount should be in accordance with the B.Tech. fee. Currently, the Institute charges a fee of Rs. 10,000/- (approx.) per credit from the B.Tech. students (the annual fee for the B.Tech. program is approximately Rs. 4 lakhs and the B.Tech. students are required to do 20 credits per semester). The AAC recommended a fee of Rs. 10,000/- per credit and a refundable security deposit of Rs.10,000/-. This fee will get automatically revised if there is a revision in the B.Tech. fee. This will be adopted for all professional candidates, i.e., nondegree visiting students and industry folks. A transcript will be issued to all registered candidates in a format similar to that of the transcripts issued to our regular students. Mr. K. P. Singh mentioned that we already have guidelines for the registration of professional candidates. The AAC desired to review these guidelines in the upcoming AAC meeting.

In the 17th meeting, the AAC discussed existing guidelines for Professional Candidates Registration (PCR) in regular courses at IIIT-Delhi. It was noted that as per the existing guidelines, a Certificate of satisfactory completion of a course will be issued to only those candidates who have received at least a 'C-' grade in the course. However, according to our metric, the letter grade 'C' is equivalent to satisfactory performance, so the AAC recommended issuing this certificate to only those candidates who have received at least a 'C' grade (instead of a 'C-' grade) in the course. The AAC also recommended issuing a transcript mentioning the name of the course, the number of credits and the grade received to all the registered candidates after completion of the course. The AAC had already recommended a fee revision in the 15th meeting. Except for the above-mentioned points, the AAC agreed with the remaining guidelines.

The revised rules for Professional Candidates Registration (PCR) are placed as Annexure VIII for approval of the Senate and the Finance Committee.

Arising out of the discussion, the AAC recommended that henceforth, the cases of Professional candidates will be dealt with by the Academic Section. The advertisement for the course(s) will be made through the website and social media. Besides, wherever necessary, the academic section will seek support from the Placement and Alumni divisions. The list of companies prepared for the Industrial Doctoral Program should also be used for publicity purposes."

During the course of discussions the members made some queries which were answered by the DoAA. After detailed deliberations, the Senate approved the above-mentioned recommendation of the AAC and further recommended it to the Finance Committee, the revised rules for Professional Candidates Registration (PCR) placed at Appendix-VII.

Action: Academic Section

53.5.3.8 To report admission of Pulkit Nargotra to B.Tech. (CSAM) through JAC 2021 and award of PMSSS scholarship, Academic Year2021-22, on his own.

The Dean of Academic Affairs informed that for Pulkit Nargotra admitted to B.Tech. (CSAM) through JAC 2021, we have received an allotment letter, F.No. J&KSSS/2021-22/Couns/2021319509 from AICTE under Prime Minister's Special Scholarship Scheme (PMSSS). During discussions, it was noted that the admissions on the basis of PMSSS (supernumerary) were not undertaken during the last two years on the directions of the Board as the fee compensated by the AICTE was lesser than the fee charged by the Institute. However, in the present case, the admission has been made through the JAC and PMSSS is just a financial support. It can be considered favourably provided the student pays the complete fee upfront under an undertaking clearly spelling that he will continue to pay the full fee to the Institute irrespective of the payments/support under the PMSSS. In case the PMSSS money directly comes to the Institute, the same can be refunded to him. In view of the above it was proposed to facilitate the student to receive the PMSSS scholarship from AICTE by taking an undertaking from him to the effect that he will continue to pay the full fee to the Institute irrespective of the payments/support under the PMSSS.

After detailed deliberations, the Senate approved the above proposal and recommended that the same may be reported to the Board of Governors for information.

53.5.3.9 To consider the recommendation of the Academic Affairs Committee (AAC) to allow faculty of IIIT-Delhi to Teach in sister institutes like IITs/NITs/ISIs/ etc.

The Dean of Academic Affairs apprised the members of the recommendations of the AAC made at its 16th meeting held on January 19, 2022 to allow faculty of IIIT-Delhi to teach in sister institutes like IITs/NITs/ISIs/ etc. During the course of discussions the members expressed their views and made a number of suggestions. After protracted deliberations the Senate desired that the Insitute should come up with a comprehensive policy covering all the concerns as discussed in the Senate meeting. The policy may be placed in the next Senate meeting.

53.6 Plan to open the Institute

Ms. Khushali Verma and Mr. Navneet Agarwal, Student representatives raised the issues related to the plan for the opening of the Intitute and the difficulties being faced by students in the online teaching mode. The Dean of Academic Affairs informed that the matter is under active consideration of the Covid Care Committee and the Institute is open to the students. However, for the offline conduct of Academics, the availability of the physical resources for maintaining social distancing is to be considered. Also, fair consideration of the non-Delhites, as well as, foreign students is also important and the same is being looked into for the start-date of offline teaching. Once the decision is taken, it will be announced to all concerned.

The meeting ended with a vote of thanks to and by the Chair.

Regulations for the Dual Degree Program in Computational Biology (CB)

1. Preamble

Dual degree programs are common in India and most IITs have it. The main motive behind such a program is to have some of the UG students of an Institute do their M.Tech. in the same Institute, so the Institute can leverage the training it had provided and the seamless transition into the M.Tech. program to benefit its research activity, as well as reduce the duration for earning the M.Tech. degree. Most dual degree programs allow for both degrees to be earned in five years. IIIT-D's dual degree program follows a similar approach as many other Institutions.

2. Admission and Requirements

- 2.1 The application process for the dual degree may be initiated in advance and completed well before the placement starts.
- 2.2 Application Timeline: Application for Dual Degree may be invited immediately after the declaration of the result of the 6th Semester. Scrutiny, selection of students, approval by Chair PGC and declaration of result to be completed by the middle of June.
- 2.3 **Eligibility:** Only students with a CGPA of 7.0 or above at the time of applying are eligible for the program. A student once selected for the Dual Degree cannot avail placement services that year. Furthermore, a student selected for the Dual degree may opt-out from migration before the add/drop date of his/her 7th semester in the B.Tech. program. The refund of the fee paid towards the dual degree will be regulated as per Note 3.6 of this Regulation.
- 2.4 **Transfer of 12 credits**: Any extra course credits earned during the B.Tech. program beyond what is required for the B.Tech. degree, up to a maximum of 12 credits as approved for the M.Tech CB program, may be counted towards course credit requirements for the M.Tech. degree. So, a student can do extra courses in the 3rd and 4th years (as Honors students do), and get these credits counted towards satisfying the M.Tech. course credit requirements, provided the courses are such that they can be counted for M.Tech.
- 2.5 **Waiver of 12 credits**: Students, who have undergone B.Tech. (CSB) program of IIIT-D, have the necessary background and strength in foundations for M.Tech.(CB) program. Hence, only up to 12 credits of the core course requirement of the M.Tech. program, which is designed to impart some core knowledge to students, is deemed

to have been satisfied, and the same is waived-off for the dual degree students for earning their M.Tech degree.

(a) The following three M.Tech.(CB) core courses will be waived off only for students of the BTech (CSB) program: a) Cell Biology and Biochemistry (CBB) b) Foundations of Modern Biology (FoMB) c) Algorithms of Computational Biology (ACB).

Note: As Introduction to Mathematical Biology (IMB) is also a core course for M.Tech(CB), a dual degree student need to complete this course which is not waived; If a student has done IMB course as part of B.Tech. program requirement and not able to transfer that credit with the clause mentioned in 2.4 in this regulation, the student will have to do a BIO-numbered course in lieu of that.

(b) The core course requirements cannot be waived off for B.Tech (CSE), B.Tech (ECE), and other B.Tech (CS+X) students, including those who have done a minor in CB. Though, up to 12 credits can be waived if a student has done BIO-numbered courses in their undergraduate program (only counting at most one 3xx level and two or more 5xx level courses). If a student has done M.Tech (CB) core courses as a part of their electives, then in lieu of these courses, he or she will have to do other courses from the M.Tech (CB) curriculum.

Note: The courses considered for transfer of credits with the clause 2.4, can't be considered for waiver.

- 2.6 Mandatory requirement to complete OOPD course can be waived for Dual Degree students if they have taken AP during B.Tech.
- 2.7 Mandatory requirement to complete RM course can be waived for Dual Degree students if they have taken RMSSD during B.Tech.
- 2.8 A dual degree student will be considered as a B.Tech. student till the time he/she completes the requirements for the same; thereafter he/she will be considered as an M.Tech. student. The date for each degree will be based on the date of completing the requirements for that degree.
- 2.9 The dual degree student must spend at least two semesters as an M.Tech. student.
- 2.10 A dual degree student must do an M.Tech. thesis, which may be a continuation of the work done in BTP. The goals of the MTech thesis should be aligned with the objectives of the MTech (CB) program.

3. Notes:

3.1 The fee for the M.Tech. portion of the dual degree program will be half of regular M.Tech. fee.

- 3.2 The dual degree student will not be eligible for campus placement in his/her B.Tech. portion, and will be eligible only in his/her last year to use placement services.
- 3.3 If a student does 12 credits extra in 3rd/4th years, as allowed, he/she will have to do 8 credits more in the 5th year, and at least 16 credits of M.Tech. thesis, for the M.Tech. degree. The minimum number of credits for M.Tech. part under the Dual Degree program is 36.
- 3.4 After the declaration of 8th-semester results, the student should specify which courses should count for B.Tech. and which for the M.Tech. degree.
- 3.5 Students should be encouraged to take GATE in their 4th year to benefit from the scheme.
- 3.6 It is clarified that after admission to the Dual Degree program the student is ineligible for placement. No refund of the fee will be made if he/she does not join except if he/she goes for higher studies in which case some amount is deducted (the amount to be deducted will be decided by the Competent Authority).
- 3.7 On completion of B.Tech. requirements, the B.Tech. degree may be given on submission of No Dues Certificate.
- 3.8 If he/she cannot complete the M.Tech. part of the Dual Degree program, no fee refund can be made.
- 3.9 Internship rules for dual degree students will be the same as for M.Tech. students of the respective batches.

RULES FOR PROFESSIONAL CANDIDATES REGISTRATION (PCR)

Professionals working in Industry, Research Laboratories, Government Departments/Agencies, etc. who are interested in attending one or more courses for their self-development/knowledge up-gradation would be governed by the following Rules and Regulations:

- 1. A professional candidate is defined as the one who is employed in an industry, a Govt. Organization, Research Laboratory, etc.
- 2. Course instructors can decide whether to accept professional candidates in their respective courses. Such courses, where the instructor has agreed, will be advertised to attract good professional candidates.
- 3. The fee per credit will be computed in accordance with the prevailing first-year fee of UG programs, i.e., by dividing the annual fee of the first year B.Tech. student by 32 credits, and approximating it to the nearest 1000 rupees. Currently, for years 22-23, it comes out to be Rs. 10,000 per credit.
- 4. In addition, a professional candidate will be required to deposit a 'Security Deposit' of Rs.10,000/- (refundable).
- 5. The Head of the Department, in consultation with the course instructor, would check the qualification and necessary background for all such applications. The eligible candidates would then be recommended to DOAA for approval.
- 6. All professional candidates attending courses will have to satisfy all the course requirements similar to other regular students, e.g., appearing in all evaluations, submitting assignments, projects, etc.
- 7. After completion of the course, the institute will provide a transcript to each candidate mentioning the name of the course, the number of credits, and the grade received.
- 8. Based on the performance, a candidate may also be awarded a certificate of satisfactory completion of the course, if and only if the grade received in the course is at least a 'C' grade.
- 9. All candidates would be issued a temporary Identity Card.
- 10. They would be allowed to use the Library facility for consultation purposes only. They will not be allowed to use any other facility available for regular students such as sports, gym, etc except the food outlets where services are rendered on payment basis such as canteen, cafeteria etc.
- 11. Candidates will be provided with all the facilities required for the coursework.
- 12. Such candidates will not be registered for Thesis, Independent Study, BTP and other such courses which do not have lectures.
- 13. A professional candidate is not entitled to campus accommodation.
- 14. The Institute will not be liable for any damages on account of any injuries/loss sustained by such candidates during their coursework at the Institute.
- 15. The relevant terms and conditions may be suitably incorporated in the offer of admission.

1. Background

In August 2021, we lost our student, Kartikeya Gupta (2018153: B.Tech. ECE), after a long battle with cancer. Kartikeya was an academically brilliant student and was actively involved in extracurricular activities. His friends, peers, and seniors fondly remember his caring and helpful nature. He had a dream of starting his own company and was passionately working on the same. He loved IIIT-Delhi's culture and left a top-tier institute to pursue B.Tech. at IIIT-Delhi. His parents (referred to as donors hereafter) would like to support meritorious students via Kartikeya Gupta Memorial Scholarship and live his dream of giving back to his favorite place – IIIT-Delhi.

2. Number of Scholarships: One (1) per year

3. Amount of Scholarship: INR 1 lac per year

The donor, depending on the total interest available, reserves the right to increase the above-said amount or number of scholarships, from time to time.

4. Eligibility:

The candidate should:

- Be a regular B.Tech. student in the third year of engineering
- Have passed all the branch-specific core courses with a CGPA of 7.5 or above
- Not have any academic warning in the first three years
- Not have any case referred to DAC against him/her
- Have active engagement and impactful contribution at national and international levels in extracurricular activities including sports, arts, music, community services, etc.
- Bear a good moral character.
- The student should not be in receipt of scholarship from any other source.

5. Application for Scholarship

- The application shows the willingness of the candidate for the acceptance of the Scholarship. Thus, each of the eligible candidates should apply for the Scholarship in the prescribed application format.
- The application forms for each year will be made available on the institute's website in the month of June each year.
- The last date of submission is June 30 of each year.
- Applications received after the due date will not be considered.
- The candidate should enclose all the necessary documents, described in the application form, after due attestation by the competent authority. In the absence of these, the application may, summarily, be rejected.
- Only online submissions will be accepted.

6. Administrative Management of the Scholarship

- The administrative management of the Scholarship will be done by the academic section of the IIIT-Delhi.
- The academic department will verify the applications and prepare the list of short-listed candidates.

• The Department will maintain a record of all the applications received and granted for various years.

7. Selection Committee

- All the applications received will be scrutinized by a "Selection Committee".
