MINUTES OF THE MEETING

60.1 WELCOME AND OPENING REMARKS BY THE CHAIRPERSON

At the outset, the Chairman, Senate welcomed all the members/special invitees to the 60th meeting of the Senate, participating in-person or online. He also informed that Mr. Sunil Kant Munjal, Chairman, Hero Enterprise, has kindly agreed to be the Chief Guest at the 12th Convocation scheduled to be held on October 27, 2023. Also, from this year the Institute is switching to the traditional Indian attire for the Convocation. Thereafter, he requested Dr. Sumit J Darak, the Dean of Academic Affairs to present the agenda items.

60.2 CONFIRMATION OF MINUTES OF THE 59th MEETING OF THE SENATE

The Dean of Academic Affairs informed that no comments were received on the Minutes of the 59th meeting of the Senate held on August 11, 2023. The Senate, therefore, confirmed the Minutes of the 59th meeting as circulated.

60.3 ACTION TAKEN REPORT

The Dean of Academic Affairs apprised the members of the action taken on the various decisions taken by the Senate in its 59th meeting held on August 11, 2023. The Senate noted the position.

60.4 ITEMS FOR INFORMATION/ RATIFICATION

60.4.1 Reporting items

60.4.1.1 To report the status of Cycle 3 NAAC accreditation

The Senate was informed that for Cycle 3 NAAC accreditation, the AQAR for AY 2021-22 has been initiated, and the deadline for filling out the form is now extended till December 31, 2023. The Senate noted the position. The Senate also noted the AQAR submitted for AY 2020-21 as per Annexure III of the agenda note.

60.4.1.2 To report the list of students whose names were struck off from July 1, 2022 – June 30, 2023

The Senate noted the list of students whose names were struck-off from the rolls of the Institute during July 1, 2022 - June 30, 2023 as detailed in the agenda note. During the course of discussions, the points raised by the members were clarified by the DoAA.

60.4.1.3 To report the conduct of Summer Camp 2022 & 2023 for Govt. School students.

The Dean of Academic Affairs informed that IIIT-D hosted the 6th and 7th editions of the Summer Camps for Govt. School students in a completely offline mode after the COVID pandemic; the detailed reports are placed at Annexures V and VI of the agenda note. The Senate noted the same and appreciated the efforts made by all concerned.

60.4.2 Items for Ratification

60.4.2.1 To ratify the approval given by the Chairman, Senate to allow Mr. Aatish Sahai, 2018 batch CSSS complete core/compulsory courses through Independent study as an exception.

The Senate was informed of the case of Mr. Aatish Sahai, 2018 batch CSSS student and the approval accorded by the Chairman, Senate to the proposal of the Department as detailed in the agenda note. After a brief discussion the Senate ratified the approval accorded by the Chairman, Senate.

60.4.2.2 To ratify the approval given by the Chairman, Senate for making changes in the Academic Calendar of Monsoon Semester 2023.

The Dean of Academic Affairs apprised the members of the background for making changes in the Academic Calendar of Monsoon Semester 2023 on account of G-20 summit and 12th Convocation as mentioned in the agenda note. After a brief discussion the Senate ratified the approval given by the Chairman, Senate.

60.5 ITEMS FOR DISCUSSION AND CONSIDERATION

60.5.1 UG Matters

60.5.1.1 To consider the recommendation of the Academic Affairs Committee (AAC) to count the mentioned 2 courses towards a Minor in Entrepreneurship and add it to the regulations.

The Senate was informed that the Academic Affairs Committee (AAC) in its 30th meeting held on August 26, 2023 noted that a proposal for counting the below mentioned 2 courses towards **Minor in Entrepreneurship** was circulated among AAC members over email and the same has been approved for counting and adding in the regulations:

Design for Artificial Intelligence driven Products (DES 529) The Business of Artificial Intelligence (DES 530)

During the course of discussions Prof. Kaushik Saha, one of the external members, made some queries which were answered by Dr. Richa Gupta. Dr. Richa was also requested to take appropriate action on the suggestions made by Prof. Kaushik Saha and come up with a justification for adding these courses for further consideration in the upcoming Senate.

60.5.1.2 To consider the recommendation of the Academic Affairs Committee for the sanction of Additional B.Tech. seats to take care of withdrawals for the Academic Year 2024-25.

The Dean of Academic Affairs informed the members that the Academic Affairs Committee (AAC) in its 31st meeting held on October 04, 2023 looked into the trend of withdrawals over the year (Table 1) and after a protracted discussion, the AAC recommended the following for the upcoming year's admission in B.Tech. program;

Recommendations:

- 1. AAC suggested having provision of a special spot round before starting the first-day class, if there are vacancies. The admission committee may take a call on whether to conduct this round.
- 2. The AAC will further discuss the alignment of the start of the semester so that there will be enough time between the spot round and the start of classes. This will be decided, taking input from all stakeholders.
- 3. It was also proposed to add 5% additional seats to the existing intake, which will take care of the withdrawals made after the last date of admission from the upcoming admission cycle. For regulatory bodies, there will be no change in the intake number. This increase in number is being introduced to take care of the withdrawals. While preparing the final reservation chart for admissions, these 5% additional seats will be included. Hence, the proposed intake for the Academic year 2024-25 will be as follows:

60.5.2 PG Matters

60.5.2.1 To consider the recommendation of the Academic Affairs Committee (AAC) for Vehant Fellowship for M. Tech. (Research) students

The Senate was informed of the Vehant Fellowship for M.Tech. (Research) students and the recommendation of Academic Affairs Committee (AAC) made in its 30th meeting held on August 26, 2023 as detailed in the agenda note. After a brief discussion, the Senate approved the recommendation of the AAC.

60.5.2.2To consider the recommendation of the Academic Affairs Committee (AAC) to clarify the PG Regulations clause 8 (1) a (i-vii), page 10.

The Dean of Academic Affairs informed the members that the AAC in its 31st meeting held on September 29, 2023 re-discussed the applicability of the following points that were approved in 57th Senate (Ref.57.6.2) and subsequently updated in Clause 8 (1) a (i-vii) on page 10 of the PG Regulationsprovide as under:

i. If a PhD student does not register on ERP, (s) he will be marked "Absent Without Leave", and his/her fellowship and other facilities will be stopped immediately.

ii. The Annual Review shall be made mandatory for all Ph.D. students, even after 5th year of Ph.D. and no exceptions will be granted for annual reviews and as long as any Ph.D. student remains registered in the Ph.D. program, they will have to appear and clear the annual reviews regularly.

iii. After the 5th year of Ph.D., the default fee waiver will be stopped. The student must pay a fee equivalent to the fee applicable to sponsored students, failing which his registration shall stand terminated. The Advisor(s) may request for a waiver of fee in genuine cases [subject to satisfactory performance in yearly review.]

iv. After completing 7 years in the Ph.D. program, all Ph.D. students will be required to pay a fee equivalent to the fee applicable to sponsored students mandatorily. The fee waiver request will not be accepted in any case.

v. Ph.D. students can be allowed to register courses and complete the program within a maximum of 10 years.

vi. The maximum duration of the Ph.D. program will be 10 years from the date of joining. If a Ph.D. student does not submit his/her thesis within 10 years from the date of joining, his/her registration will be terminated and a termination letter will be issued to the student with a copy to the Head of the Department and to the Advisor(s)

After a brief discussion, the AAC agreed that these rules will be applicable from the Academic year 2023-24 and the Senate approved date will be considered as Day zero for all students.

During the course of discussions, the DoAA clarified the points raised by the members. After detailed deliberations the Senate approved the above recommendation of the AAC. As for the exceptional cases requiring special consideration, the case may be considered by Chairman, Senate with the appropriate recommendation of the Standing committee.

60.5.2.3To consider the recommendation of the Academic Affairs Committee to Consider Reservation in PG program (M.Tech. & Ph.D.).

The Senate was informed that the Academic Affairs Committee (AAC) in its 31st meeting held on October 04, 2023 discussed the reservation in the PG program as per the directions of BOG.

After an in-depth discussion, the AAC proposed the following:

1. The national reservation policy in admissions may be announced for the M.Tech. programs adopting the B.Tech. reservation norms and the conversion rule. The proposed reservation to be followed is placed in **Appendix I**.

In addition, it was also proposed that currently, relaxation is given only in the eligibility criteria, which may be extended to the final selection criteria. Here, the cut-off for various reserved categories may be defined separately to prepare the merit list.

It was also proposed to have the same intake as last year for the academic year 2024-25, adopting the reservation. Hence, the proposed intake for the Academic year 2024-25 will be as follows:

(Similar to B.Tech. for regulatory bodies, the intake number for M.Tech. will be excluding the 15% additional seat).

2. For the Ph.D. programs, it was suggested to highlight the relaxation criteria for reserved category appropriately to attract more applicants from the reserve categories and to also mention that candidates from the reserve categories are strongly encouraged to apply. However, the interview and selection norms will continue as per current practice.

After detailed deliberations the Senate agreed to the recommendation of the AAC and recommended the same for approval of the Board of Governors.

60.5.2.4To consider recommendation of the Academic Affairs Committee (AAC) for Course work relaxation for a Ph.D. Student of Mathematics Department

This matter was discussed in 30th AAC Meeting, where the department was requested to discuss the proposal, the department has discussed it and below is the updated proposal

A Ph.D. student in the Department of Mathematics has done M.Sc. (Mathematics) + M.Tech. (Industrial Mathematics and Scientific Computing). Currently, in the PG regulations of the Mathematics department, there is no mention of the course work of the students who come with M.Tech. degree in a related field.

Based on the department's suggestion, as per clause 16.2(b) of the PG regulations, the following request for the concerned student is made:

As there are no guidelines regarding students who have done M.Sc. (Mathematics/related fields) + M.Tech. (in related fields), the concerned student should be allowed to do 16 credits of coursework. He has done M.Sc. in Mathematics from IIT Delhi and MTech. in Industrial Mathematics and Scientific Computing from IIT Madras; based on the background, AAC to provide him the relaxation.

The AAC deliberated and approved the above proposal and recommended the same to the Senate for approval.

After a brief discussion the Senate agreed to the recommendation of the AAC.

60.5.3 Other Matters

60.5.3.1 To consider the list of students who have completed graduation requirements and are eligible for a degree in Convocation 2023

The Dean of Academic Affairs informed the members that the students who have completed Graduation requirements on January 21, 2023, June 21, 2023 and September 21, 2023 are eligible for the award of degrees in the 12th Convocation of the Institute. 60.6.3.5To Report the Academic MoU between IIIT-Delhi and IHUB ANUBHUTI-IIITD FOUNDATION (iHub-Anubhuti).

The Dean of Academic Affairs informed the members that in the 59th Senate meeting held on August 11, 2023, it was apprised to the Senate for starting possible joint PG Diploma and certification programs. Accordingly, an MoU has been signed. He also informed that as per the MoU norms a Joint Steering Committee (JSC) has also been formed which met on October 06, 2023 to discuss the operations and implementation of the MoU. The committee also looked into the current work flow for approval of PG Diploma program and suggested some changes as detailed in the Agenda note. After deliberation, iHub will put up the proposal of starting a PGD program through JSC for in principle approval of BoG. The other processes will remain same to have a check on the quality of the program. The Senate noted the same for information.

While concluding the discussions the Director/(Chairman, Senate) thanked all the Senate members/special invitees for their significant contributions during the deliberations and invited all of them to attend the Convocation ceremony scheduled on 27th October, 2023.

The meeting ended with a vote of thanks to and by the Chair.

Reservation

In category

a) Scheduled Castes (SC): 15 % of the total seats.

- b) Scheduled Tribes (ST): 7.5% of the total seats.
- c) Other Backward Classes (OBC-NCL): 27% of the total seats.
- d) Economically Weaker Section (EWS): 10% of total seats

Sub – category

e) Defence Category(CW): 5% of the total seats in each category are reserved for candidates belonging to the Defence Category' in various priority. (Will be similar to B.Tech)

f) Differently-Abled Persons (PD): 5% of the total seats in each category are reserved for candidates belonging to the 'Differently Abled Person"

Relaxation

Scheduled Castes (SC) and Scheduled Tribes (ST): A relaxation of 10% marks in the eligibility requirements for the seats reserved for them.

Defence (CW): A relaxation of 5% marks in the eligibility requirements for the seats reserved for them.

Persons with Disability (PWD): A relaxation of 5% marks in the eligibility requirements for the seats reserved for them.

OBC: A relaxation of 5% marks in the eligibility requirements for the seats reserved for them.

Note: No relaxation for EWS.

Conversion of Seats:

In the case of categories (a) and (b) of SC and ST, the vacant seats are interchangeable. If the merit list is exhausted for SC & ST, then the vacancies will be treated as unreserved.

If sufficient numbers of eligible candidates from the categories mentioned in (c) and (d) are NOT available, the vacancies will be treated as unreserved.

Seats under category (f) are interchangeable within the category if sufficient candidates are not available in a particular sub-category.

In case a sufficient number of eligible candidates from the categories mentioned in (e) and (f) above are not available, the vacancies will be treated as unreserved in the respective category.

Note: The conversion of seats will be made in the round where the merit list is exhausted in the respective category.
